A Brief Analysis of the Data Findings

The data shows that 100% of the candidates scored at the acceptable or target level for this assessment. For standard 1.1 80% (28 candidates) scored at the target level and 20% (7) at the acceptable level. For standard 1.2 about 97% (34) scored at the target level and about 3% at the acceptable level. For standard 1.4 80% (28) scored at the target level and 20% (7) at the acceptable level. For standard 1.3 83% (29) scored at the target level and 17% (6) at the acceptable level. For standard 3.1 80% (28) scored at the target level and 20% (7) at the acceptable level. Lastly, for standard 5.1 about 89% (31) scored at the target level and about 11% (4) scored at the acceptable level. Overall, about 84% of the evaluated elements are scored at the target level and 16% at the acceptable level.
