Agenda Item: Introductions and Updates

- Michelle Prevention Expansion Grant (request for information to the State- expanding prevention services for 4th and/or 5th grade (does not have to be both grades; they were awarded funding plan on hiring 1 ½ people; 8-10 sessions for evidence-based programs); Currently looking at Shelby and Moultrie Counties to implement this program Katie Wienke might be a good contact for this
- Communication around Edgar County (HRCEC is currently the SUPPS provider so they might be the best agency to implement this education)

 - Program Director at Hour House is doing the hiring; Karen is happy to field any application questions

 - Matthew will talk with Douglas County museum to see if they would like to be a host for Tuscola (Matthew will connect Karen will the appropriate contact); additionally, Matthew will look into Newman State Park

Agenda Item: Strategic Goals Update and Review of Community Health Needs Assessment

- How can we enhance our current strategic goals?
 - We need community collaboration and support to address these efforts!
 - Last month we looked at health promotion; look at harm reduction/intervention
- Discussion on Intervention/Harm Reduction:
 - Drug Court (Karen/Jason have had a few conversations around this)
 - Update from Jason: had the opportunity to meet with the Judge to have the drug court discussion (funding, staffing, and lack of resources – time issue as well)
 - Douglas County resources need to be in place (treatment resources in Douglas County)
 - Sara mentioned that Cumberland County is in a similar boat (lack of overall resources; but they ended up partnering with a neighboring county)
 - Jason said that certification through the State is needed, but a foundation is needed first (ensuring that treatment services are in place)
 - Karen shared that drug court is an opportunity for folks in recovery, however, she mentioned that it is extremely lengthy and might be a multiple year project (little steps are needed)

- Karen emphasized the importance on HOW we want to get to a drug court; right now we need to focus on the little steps so we do not get defeated
- Jason highlighted the importance of the Recovery Navigator role
 - Karen mentioned that maybe this is something we want to add to the strategic goals (i.e. specific roles of RN's)
- Pushing the importance of establishing jobs/goals for individuals in recovery
 - Goal in Douglas and Piatt Counties
 - Workforce development
 - Group presentations available if needed
 - Current partnership with Champaign County Probation Department
- Matthew Hales- safe consumption sites
- Jason- school involvement, school presentations, civic organizations (Moose, Kiwanis, American Legion, Churches, etc.)
- Stacy Welch students feel like they do not have anyone to talk to; they do not want to talk to teachers (Operation Hope offers this opportunity for students to come together)
 - Reflection back on student event at Newman Library this summer
 - Multiple students are needing mental health support (this circles back to stigma within the community)
 - Jason said that he has previously received great feedback when going into classrooms – Jason mentioned RISE as being a support for students
 - Looking at other models (such as Big Brother Big Sisters) that have been successful in the past – help students know how to access resources
 - Quarterly Events for students
 - Linking students with adults who do not live in the same town (Stacy)
- Jason mentioned DCFS/representation on the ROSC
 - Sarah has the same licensure as DCFS
 - Educators are missing at the table
 - Jason Youth Advocate Program (previously served Douglas County)
 - Office in Charleston (unsure if they still serve Douglas)
