**Sponsorship:** The five (5) GovState 2024 Campus Sexual Misconduct Climate Survey Participation Weekly Drawings (each a "Weekly Drawing" and collectively, the "Weekly Drawings") are sponsored by the Board of Trustees of Governors State University, a body corporate and politic of the State of Illinois (the "University"), located at 1 University Parkway, University Park, IL 60484. The University's Center for Student Engagement and Intercultural Programs ("CSEIP") and Office of Compliance and Ethics ("OCE") are responsible for administering the Weekly Drawings (CSEIP and OCE are collectively referred to in these Official Rules as "Sponsors").

**Eligibility:** The Weekly Drawings are open only to active enrolled students at Governors State University (the "University") aged 18 and over and physically located within, the fifty (50) United States and the District of Columbia, age eighteen (18) years or older at time of entry. Void where

prohibited. All federal, state, and local laws and regulations apply. Employees, representatives, and agents of CSEIP and OCE, and their immediate family members (herein, defined as spouse, siblings, children, and each of their respective spouses, regardless of residence and any person living in such a person's household, whether related or not), are not eligible to participate. Participation constitutes a person's full and unconditional agreement to and acceptance of these Official Rules and the decisions of Sponsors, which are final and binding in all matters relating to the Weekly Drawings and shall not be subject to appeal.

How To Enter: To qualify for a Weekly Drawing, you must complete the University's 2024 Campus Sexual Misconduct Climate Survey (the "Survey"), click the [ENTRY] link on the last page of the Survey to access the Weekly Drawings entry form, and electronically complete and submit the entry form during the applicable Entry Period described in the "Schedule" above. On the entry form, you will be asked to provide basic contact information, including your full name and email address. You must complete all required fields of the entry form with information that is valid on the Drawing Date of a Weekly Drawing to be eligible. You need submit only one (1) entry form to enter all Weekly Drawings for which you qualify and are eligible. Sponsors will be the official timekeepers for the Weekly Drawings.
