Department of Nursing Special Admission Requirements

In addition to meeting university admissions criteria, applicants must:

- Have a BSN degree from an accredited nursing program in a regionally accredited college or university
- Complete each of the following courses within the past 7 years with a grade of C or better: Nursing Research (3), Nursing Health Assessment (3), and Statistics (3)
- Undergraduate Cumulative GPA of 3.0 AND a Nursing GPA of 3.0 or better
- Have a Valid RN License
- Applicants who do not meet the GPA requirements or who have graduated from non-graded baccalaureate programs may be conditionally admitted. A GPA of 3.0 must be maintained for the first nine hours of work completed. If a 3.0 GPA is not maintained, the student may petition the Chair of the Department of Nursing for continued enrollment.

Applicants with degrees from countries other than the United States must have their international transcripts evaluated by a NACES (http://www.naces.org/members.html) approved agency, unless the applicant is affiliated with one of Governors State University's recruiting agencies - INDUS or College Study US. If applicant is affiliated with a GSU recruiting agency, an in-house evaluation will be performed by a Foreign Credential Evaluator in the Office of International Services. Applicants must assume all responsibility for fees associated with testing and evaluating. All required credentials must be on file in the Office of Admissions before an applicant can be admitted to the program.

Other Requirements

Once admitted to the MSN program, various additional forms will be requested prior to enrollment.

Governors State University is accredited by the Higher Learning Commission of the North Central Association of Colleges and Schools.

Degree Requirements

Students must:

- Meet all GSU requirements for a master's degree;
- Maintain a 3.0 GPA for all required courses;
- Pass, during the final semester of the program, a comprehensive exam and/or give a presentation over the major area of study;
- Students must follow the Student Study Plan (SSP); the student's Academic Advisor or the Department Chair must clear any deviations.

Program Requirements

- A student must earn a grade of B or better in all clincal courses
- A student may repeat **ONLY (1)** nursing course in which a grade of "C" or below is received. A second "C" or below will result in dismissal from the program.
