- **advanced work within my program.** This may include contracting with an instructor in their program to do advanced work within an existing course, completing a 4000 level course at the graduate level (5000 or 6000), or taking a graduate course within their program. Evidence of this will be a letter from the course's instructor stating that I have fulfilled this requirement.
- one advanced **interdisciplinary Honors Seminar** which I will complete with a grade of B or higher.
- an **honors thesis/project/internship** which is completed under the supervision of a faculty mentor. Evidence of this will include a letter from my mentor.
- a **minimum of a 3.6 GPA** for credit taken at GSU at Graduation.
- Last, it is my responsibility to compile all letters and other evidence of my successful completion of the Honors Program and to forward these materials to the Honors Director so they may be included in my Honors File.

In return, I will be granted all benefits, privileges and considerations that come with being a member and a graduate of the University Honors Program at Governors State University.

## Adult Photo Release
