Call to order

- Introductions, Announcements (St. Clair County Health Summit March 28th, Meth Conference – April 17th and 18th).
- MOUs/Needs Assessments Chairperson asked any present Council Members to turn in any signed MOUs or completed Community Needs Assessment.
- 3. **Recovery Trivia** Chairperson asked five (5) trivia questions related to recovery.

- MERC Member Challenge Members were challenged to bring one new person to the April 11th meeting.

The social media-based video series will have new episodes monthly and will cover health and wellness topics and unsung heroes in Madison County (e.g., addiction, mental health, chiropractic, etc.).

Employment and Recovery Advisory Board Briefing Beckie Marshall with Madison County Employment & Training Department informed MERC that Sara Ray Lorio, Ty, and her met to begin forming the Employment Advisory Board (EAB).
