 - b. This provided focus for a growing advocacy force among people in long-term recovery from addiction to alcohol and other drugs, their families, friends, and allies to bridge the gap in public understanding of recovery to:
 - i. End discrimination
 - ii. Obtain equal healthcare treatment
 - iii. Incorporate family recovery
 - c. Mission: Changing the way addiction and recovery are understood and embraced through advocacy, education, and leadership.
 - d. Vision: We envision a world where the diverse voices of individuals and families affected by addiction are embraced and connected in communities, free from discrimination and injustice.
 - e. Values: Authenticity, Integrity, Wellness, Leadership, Diversity, Inclusion and Participation, Equality, Equity, Activism. F&V strives to make a place for everyone at the table.
 - f. Advocacy is such an important part of F&V work. Our Advocacy, Research & Innovation work helped bring much-needed increases to two critical programs housed under the Substance Abuse and Mental Health Services Administration (SAMHSA). One of these is the Building Communities of Recovery (BCOR) Program, which received an increase of \$3 million.
