- <u>Illinois' Opioid Settlement Overview:</u> Dana Rosenzweig, St. Clair County Mental Health Board & Deborah Humphrey, Madison County Mental Health Board presented on both counties' plans for the allocated amounts for each county. According to Dana, St. Clair County Mental Health Board will serve as the overseer of the distribution of Remediation funds in St. Clair County; Deborah clarified that approval of the Abatement funds will go through Madison County Board. A breakdown of the settlement in Illinois was provided by Dana, which will be disseminated to the council by Beverly.
