Please spread the word! Illinois Recovery Corps are recruiting members across the state for the 23-24 program year starting in August!

Recovery Corps is a program that hires, trains, and deploys people at a variety of organizations throughout Illinois for an 11-month service term.

There are two different programs positions under the Recovery Corps umbrella:

- 1) Recovery Navigators: These are individuals in recovery from substance-use disorder and provide direct peer-support and resource navigation services for people in all stages of their recovery journey, helping them navigate the complex of web services (housing, employment, health, re-entry, etc..) and set and achieve specific goals to sustain their recovery.
- 2) Project Coordinators: These are people who provide capacity-building services for the organization they serve at. Their projects are defined by whatever the unique needs of partner sites are so that the site can more quickly and thoughtfully able to address addiction. This includes things such as database management, program evaluation, public education campaigns, and strengthening internal or external collaborations, just to name a few.

All members receive robust training and professional development throughout the year, along with \$1,100 living stipend every two weeks, an education award of up to \$6,895 to pay for school or pay back student loans and free health insurance and childcare assistance (for those who qualify).

We currently partner with nonprofits and public entities, such as outpatient treatment centers, recovery community organizations, harm reduction organizations, collegiate recovery communities, state and local agencies, recovery residences, and larger social services organizations.
