MEETING MINUTES

- 1. Attendance: Heather Creasy-HYFS, Ken Sterner-II National Guard Counterdrug Taskforce; Cara Loddeke-PLE; Randy Haselhorst-PLE; Melissa Monte-The Aviary; Tisha Lancaster-DCFS; Mary Pianfetti-FLE; Craig & Deb Loddeke-PAL/FSN; Chestnut: Deb Beckmann, Toni Randall, Beverly Holland, Julie Pohlmann, Alicia Moesner, Dan Hutchison.
- 2. Sub Committee Reports: (we need people to serve on committees and help with our work!!)
 - A. <u>Education & Prevention</u>- Heather Creasy-Chairperson (Hoyleton Youth & Family Services): Working on ideas for schools for NIDA Week in March and NPW week in May. Toni suggested doing something with Kaskaskia College for NIDA Week and Deb suggested reaching out to Amy Troutt. Heather shared an opportunity with SAMHSA for a \$750 stipend coalition might be able to apply for. Deb reported she did a Zoom recorded training for the ROE#13 about how schools/educators could work with TAC for prevention education with our youth. The ROE wants us to do some more trainings with them. Deb will get with them in February.
 - B. <u>Law Enforcement</u>- Jon LeCroy-Chairperson (Officer with Aviston/Chief-Beckemeyer Police Departments) Jon was unable to attend but group has questions about why the person he encountered was not able to spend the night in jail. Group thought there was a mandate that required such a stay in the situation Jon was in. Put talking to the sheriff about this. Beverly suggested talking to Violette Book about the Choice Deflection Initiative.
 - C. <u>Treatment & Recovery</u>- Cara Loddeke—Co-Chairperson (PLE/Chestnut Nurse) with Alicia Moesner (Chestnut RCORP grant): Working on engaging more PLE's. Interested in grant funding to reintegrate inmates into community safely. It was noted that the State Opioid Response Grant that had funds for jail Vivitrol program ends June 2023. Cara reported that Chestnut's Maryville location will be used for MAT program a few days a week. This will be a closer location for upwards of 129 people. Randy Haselhorst, new PLE, is interested in helping us with County Sheriff/County Board contacts and discussion.
 - D. <u>Family Support</u>-Craig Loddeke-Chairperson (PAL/Family Support Network/FLE)—Facebook Page. It's called "Family, Friends and Addicts Stronger Together". Spread the word! Craig reported there were no calls to the warm line since 11/25. AMARE has been making some changes to this line and we are hoping call volume will pick up. FSN has been trying to find some PLE's/families to participate in a "Celebrating Families" training program. AMARE hired a Family Recovery Specialist that will be able to assist the Family Support Network with some of its needs. This person is looking into doing a Celebrate Recovery training. We do not have this group meeting in Clinton County.
 - E. **Finance** Deb Loddeke-Chairperson. We can't do fundraising but can seek donations to use for expenses related to securing non-profit status.
 - F. <u>Marketing</u> Craig Loddeke is Chairperson. Seeking ideas to advance our group's work and gain more members. New billboard art has been approved and is in production. Hope to see them up in early January. Group discussed new tag lines for marketing materials: "You are not alone", for FSN materials reference that is is an anonymous line, "Got a problem with drugs or alcohol? Call #...".
- 3. Meetings will be in person beginning in February 2023, 3rd Tuesday of each month, 11:00am-12:00pm, at the Breese Activity Center, 419 S. Clinton Street/480 S. 4th, Breese, IL.
