6. Advisory Board for People with Lived Experience.

* In 2023 the Advisory Board will be meeting every month on the first Wednesday of the month from 7pm-8:30pm. We meet at Toastiez on 1st Floor of the SMART building. Free drinks & \$20 GC for attending. Next meeting April 5th at 7pm. This is a very unstructured group meeting. We simply discuss ideas that we can implement to support recovery in our community.

These are topics discussed at our last Advisory Board meeting:

We talked a lot about who is welcome at our table-Some people had concerns about anonymity. At the end of the day, our table is open to anyone with "lived experience". Whatever that means to someone. Personal stories are not to be repeated. Everything else is public knowledge.

Meeting cards-we discussed how these will look when we can put them out in the community. They will be twice the size of a business card and fold in half. They will list recovery support meetings by days of the week, Monday, Tuesday, Wednesday ect. The goal is to have some sort of recovery support available every day of the week. A lot of discussion about Greenville needing an AA meeting. Clint is willing to take the lead on getting one started at the Senior Center. He will be looking into the best day of the week. We hope to have the daily meeting cards ready in the near future.

2023-We discussed ideas of things we would like to do in Bond County

National Drug Take Back Day on April 22nd from 10am-2pm-many willing to participate. It will be set up as a drive through behind the Health Department. The flyer for this is attached "Donuts for Drugs". Everything is in place so far. We are grateful to be partnering with Prairie Counseling Center, HSHS, Greenville PD, and the Sheriff's Dept on this project. We also want to thank Double J Doggie Play n Stay for donating the donuts. We will discuss further next month.
