Meeting Called to Order: Jenna Fox called the meeting to order at 9:05 am

Meeting minutes from March 25, 2023 were reviewed. Jenna Fox motioned to approve and Rick Nance seconded.

Introduction: Attendees introduced themselves.

New Business:

Outreach Subcommittee: The Outreach Subcommittee is planning a Recovery Event for Recovery month in September. The event will be held on Sept. 9, 2023 at Comer Cox Park. Planning to have partners of other community agencies to attend as they did last year. Stakeholders and committee members were encouraged to give feedback and suggestions on making the event more of a success than last year. The "Save the Date" fliers will be coming out soon.

Recovery in Action Subcommittee: The Recovery in Action Subcommittee member Kourtney Renfro communicated about an upcoming Drive Inn event that will take place on Saturday, May 13th. The premier movie will be "Guardians of the Galaxy". To date, there are 17 people who have RSVP for the event. The owner of the Drive Inn will allow the ROSC participants to enter a half an hour before the gates open to the public. There will be an hour of time before the movie to talk with to those in the recovery community about becoming members of the Recovery in Action subcommittee, and planning ideas for the next event. A meeting is being scheduled to discuss a different time/day that is more accommodating to increase membership for the committee.

Interfaith in Action Subcommittee: Jenna Fox affirmed three presentations have been given to faith based groups in the past quarter. A power point and educational materials were developed and distributed to more than 65 clergy members. Rick Nance mentioned conversations with a faith based State Wide committee and Carle Hospital Systems. Carle Hospital Systems have been gathering materials about behavioral health/substance use disorders to educate pastors in rural areas for their congregations. Rick Brown disclosed he had met with faith based organizations and shared information regarding ROSC and the services provided. Several ministers were interested after his presentation. The stakeholders and community members were invited to attend the Interfaith in Action zoom meeting on April 26th at 2:00 pm.

Other Business/Organizations: Attendees were given the opportunity to share. Jenna Fox disclosed that the Springfield Police Department had been awarded a grant. The Police Department had generously offered funding to support ROSC programs. A proposal letter has been sent and now waiting to hear back about acceptance. Sally Jefferson with Recovery Connections stated she had submitted an application for funding to SUPR. Rick Nance announced the completion of the CRSS training at FGC. There will be upcoming training and webinars for the CRSS certifications. Whitney Devine disclosed that the MAR van is going to the Washington Street Mission and the Phoenix Center weekly. They recently partnered with Locust Street Resource Center in Carlinville, and will provide services twice a month. Approval has

been granted for MAR Van to attend Pride Fest and the Illinois State Fair. The MAR Van has been in attendance at the Illinois State Capital building. The goal is to get legislators to tour the van, and be educated on how it would be beneficial to their constituent's/districts. MAR Van services and resources were verified.
