- *Angie Bailey*, with SIH, reported on recent Naloxone, with educational packets distributed in the Emergency Room. Also, reminded us that there is a med-safe disposal unit available in the hospital.
- *Andy Greer*, Gateway, updated us on the remodeling underway at one of their locations. Unfortunately this had slowed access for services and there is currently no recovery home availability.
- *Katie Unthank* updated the council on NARCAN/NALOXONE distribution numbers. She also spoke on plans to host a Drug Take-Back in our ROSC counties.
- *Drew Donelson* reported that 94 out of approximately 183 schools in our service area are supplied with NARCAN.
- *Stacey Miller* introduced *Natalie Marvel* as a new SUD counselor with the Egyptian Health Department.
