Understanding the Conflict:

Internal Conflict: Identity, Conformity, Community – Median household income America: \$74,580 Black Median Household Income \$52,860

External Conflict: Environment, Imposed Standard, Resource Deprivation, an analysis of 2019 jail admission indicate Black people made up 35% of jail admissions and only 7% of the Lake County population.

Addressing Conflict: Non-Violent, Safe Spaces, Relevant Solutions

Mindset Reset: is a Solidarity circle for Black men 18-65, online & in-person, offering resources and unity for a marginalized demographic.
