- Currently has one van right now looking to expand

- working on the process of getting Medicaid reimbursement.
- Would like to expand can ROSC work together to expand his business.
- Gets about 2 to 3 calls a day. Nobody is used to having transportation. Having flyers in the bars, medical clinics, hospitals, when not used to having something, it's a learning curve.
- Connect with Jon because they offer the same services (JM). This may be an opportunity to be an RCO as well - funding opportunity from State of IL
- Already willing to work with SFW to take people to inpatient treatment maybe come up with a voucher system
- Lincoln Recovery Center have used him in the past to give rides to inpatient treatment
- Not yet assessable for people with disabilities. If get a handicap assessable vehicle - would be great to partner with nursing homes

Accept Medicaid, Medicaid managed care, sliding scale/self-pay
