Appendix K. Harm Reduction

NARCAN is a medication that can block or reverse the effects of an opioid overdose. Anyone can easily use NARCAN to save the life of someone overdosing on opioids, including heroin or prescription medicines like OxyContin® or Percocet®. If you or your agency would like to receive additional training on using NARCAN, please get in touch with the Effingham County Health Department at 217-342-9237 or the Effingham County ROSC at samanthah@hourhouserecovery.org. If you or someone you know is overdosing and needs immediate attention, please call 911. In the instance you are with that individual, the Good Samaritan Law states that anyone who calls for help or drops off someone experiencing a drug overdose will not receive charges for possession of paraphernalia. One limitation of this law is that the person who overdosed is not covered, and any other crime committed at the scene is not protected by law.

Community Readiness

Professional and community readiness to participate in ROSC efforts have been well received. The Effingham County ROSC Council has a very active PLE committee that assists in volunteering, donations, identification of gaps, and enthusiasm to help. Individuals from other assisting organizations are engaged in providing resources, data, and ideas to the ROSC but need hands-on involvement. Effingham County provides numerous non-recovery-oriented resources to its people. Most organizations primarily focus on the client they serve as a service rather than support, so their business takes precedence during an 8 a.m.-5 p.m. work day. Little involvement from other organizations outside working hours engage in ROSC efforts. The ROSC Council continuously seeks to bring new stakeholders and PLEs to the ROSC Council table to ensure diversity.

The City of Effingham has limits and rules that make it substantially more challenging to implement recovery housing and a homeless shelter. A "not in my backyard" attitude contributes to a lack of resources for the highly impoverished. Community champions are slowly addressing this misconception.

The professional and lived experience recovery communities have demonstrated enthusiasm and willingness to participate in the Effingham County ROSC efforts, under lead agency the Hour House. The team continuously seeks to bring new stakeholders to the table to ensure that a wide array of roles and perspectives is represented. This includes those organizations and agencies listed in the Community Resources Appendix.

Priorities for Expansion

Effingham County ROSC aims to create partnerships with recovery champions of organizations, businesses, and persons with lived experience to connect individuals with direct recovery resources, support, and services. Achieving this goal will require continuous outreach with individuals met throughout the community and the ability to communicate EfCRC's goals and objectives clearly and accurately via the FY24 Strategic Plan, which has been ongoing throughout FY23. Another goal is to reduce the stigma of addiction by providing educational material and presentations to each community sector focusing on judicial, education, friends/parents, and healthcare. To achieve this goal, objectives such as education about the science of addiction, prevention, recovery, and harm reduction supplies must be presented community-wide. Lastly, EfCRC aims to provide community and family events to foster a sense of fellowship for all pathways to recovery. To achieve this goal, EfCRC will continue to attend local recovery meetings to educate peers on the ROSC concept and offer opportunities to voice suggestions, help plan events, and empower peers by delegating responsibilities. The Effingham County ROSC will require continuous outreach to remain in the eyes of the community as the county has numerous resources, events, training, and groups already provided within the county. With that being said, most of these groups are not recovery-oriented. There remains a handful of Council members who have been with Effingham County ROSC since 2019 and several new members who continue to show interest and willingness to act within the community to reduce the stigma of substance use. Effingham County remains dense in its penetrability to accept individuals with SUD. The community lacks education and resources for adolescents. The SUD problem continues to rise as the deep-rooted culture of acceptance of alcohol will take substantial time to break down.

Effingham County ROSC plans to focus on faith-based groups for FY24, as many of our churches are "hubs" for like-minded individuals who want to help build a healthier community with access to resources. Effingham County is deep-rooted in faith, and buy-ins from the community are more accessible when facilitated by a church pastor/administrator. Many participate in food pantry distribution and weekly recovery meetings within the church. Celebrate Recovery is a significant resource, and the city appears more receptive to the concept than 12-step groups.

We also focus on building relationships within Effingham County school districts to facilitate a partnership with Hour House Prevention services or another outside entity the schools deem fit for them. Healthcare is another target of expansion in the area. HSHS St. Anthony's Hospital continues seeing patients enter the ER for Detox services, with alcohol being the primary substance.

The Effingham County ROSC will require continuous commitment and involvement from its stakeholders in order to overcome many of the risks and challenges associated with community-wide change. Risks to the project effort could include member complacency, key stakeholders missed or not involved, lack of funding, loss of buy-in or interest, too many perspectives to the point the council becomes unwieldly, group think about certain priorities, and other potential

issues that may be identified further into this effort. With this in mind, some of the measures required to continue expanding the ROSC are as follows:

- Continual Council membership recruitment
- Provide training and education within the ROSC Framework
- Educational Sessions such as Stigma Reduction, MAT Services, 12 Steps, Different Recovery Paths, Pathways to Spirituality, Harm Reduction, Narcan, etc.
- Continued support for Recovery Housing, Support Groups, and RCO development within the county lines.
- Increasing awareness of harm reduction that is available within Effingham County.
- Provide education and funding opportunities to support RCO Development.
