McLean County Recovery-Oriented System of Care (ROSC) FY24 Gap Analysis

Gap Analysis Methodology:

The McLean County ROSC team used a two-part strategy to identify needs and resource gaps in McLean County. The first part of the strategy included reviewing the gaps identified by the McLean County Behavioral Health Coordinating Council in the McLean County Mental Health Action Plan (MHAP) 2022 Update. In the most recent update of the Mental Health Action Plan, the McLean County Behavioral Health Coordinating Council identified 6 key focus areas to make efforts in to improve overall McLean County mental and behavioral health. These key focus areas include: Youth (21 & Under), Collaboration & Coordination, Access to Medical Services & Medical Management, Justice-Involved, Crisis, and Housing. For the second part of this strategy, the McLean County ROSC Council provided input and feedback on these gaps, along with others not identified in the Mental Health Action Plan 2022 Update by the McLean County Behavioral Health Coordinating Council Health Coordinating Council Plan 2022 Update

Key Focus Area	Notable Gaps
Youth (21 & Under)	 The demand for certain programs outpaces the ability to provide services. Ex. Healthy Start and Healthy Families.* Embedded Schools (ES) Pilot Project – For all schools in the program, the biggest challenge and barrier is parental engagement. Several obstacles, lack of student access to phone and internet. Transportation barrier – counseling services on campus Telehealth has helped with transportation barrier
Collaboration & Coordination	 A concern of note is it appears the State is embarking on multiple different projects that are not coordinated across state agencies for mental health.*
Access to Medical Services & Medical Management	 Lack of access to medication and/or medical management for those with mental health concerns in McLean County continues to be a concern.*
