- Develop supportive communities that foster growth, respect and understanding of those who have issues in the areas of substance use and mental health.
- Implement effective communication that will allow for voices to be heard.

## How does TEECH/FSSRI aim to accomplish their goals? TEECH/FSSRI aim to accomplish their goals of uniting communities by:

- 1. Holding monthly meetings to allow for voices to be heard and strategies to be made to increase awareness of the need for collaboration.
- 2. Provide education in areas such as addiction, mental health, cultural diversity, safty, harm reduction, and health.
- 3. Develop surveys to show validity to concerns and share with those who can assist with making some changes.

## What are the expectations of those in the ROSC Council?

- Endorse the values and general principles of the Far Southside ROSC Council, as reflected in its strategic plan;
  - ▶ Community improvement and collaboration, multiple pathways to recovery, peer supported recovery, and focus on values, person-centered services, client choice and, health and wellness.
- Be active in the community providing resources for all individuals and families.
- Participate in at least (2) two in-perosn ROSC council meetings per year.
- Participate in ROSC activities, such as newsletters, sharing new ideas, data, best practices, and other important and relevant news related to the ROSC.
- Link to the ROSC website from your organization's website.
- Actively initiate and participate in collaborative activities to achieve health for all.
- Promote the work of the Far Southside ROSC council.
- Keep profile contact information up-to-date by communicating changes to Far Southside ROSC.

## Regular Meetings

- The number of ROSC council members will be determined as the council builds at present the number of ROSC council members is open-ended until further notice.
- Regular meetings shall be held monthly at a time and place agreed upon by the ROSC Council members.
- The number of ROSC Council members may be fixed or changed from time to time by the Council members without further amendment of the written protocol.

## **Special Meetings**

- Special meetings may be called at the request of two thirds of the Council members at a place and time to be determined by the membership.
- Notice of any special meetings shall be given to members at least two (2) days prior to the meeting date.

## **Compensation**

• The ROSC council members shall not receive any stated salary of compensation for their membership.

#### Indemnification

• The Council shall have power to indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative by reason of the fact that he or she is or was a Council member.

#### **Amendments**

• The membership protocol may be altered, amended or repealed by the Council members from time to time.

## Participation in meetings via Communications Equipment

 Council members may participate in and act at any meeting through the use of a conference telephone video conferencing, or other communications equipment in 3 meetings at most.

## **Confidentiality**

• Confidentiality is a must within the council. This will allow for transparency and trust with the members.
