- Kathy Straniero mentioned> We're always open at the township the second Friday of every month. I know we had one scheduled and an emergency came up so it didn't happen this past month, but for our food distribution, this would be a great thing to have an SRC table set up for community members to get info.
- Angelia Smith inquired if anyone working any other organizations or of any others that you may know of that might be willing to allow us to come and do a pop up.
- The Council shared ideas regarding opportunities for underserving and under-resourced communities with activities that we should be engaging in.
- One of the other things that we're going to be doing is setting up some focus groups for to really address the health disparities that we often encounter in some of our underserved communities.
- We'll be doing that in partnership with the Ford Heights/Chicago Heights Neighborhood Network, which is a new network.
- We will also be doing some focus groups and community cafes. And this will be a great opportunity to come out and share. And then that way any concerns, issues or recommendations that may come up as relates to recovery will be shared back with our with the with the SRC Coalition.
- A discussion was had about SRC is also offering free First Aid CPR Trainings for all member organizations of SRC.
- We are looking into, re-establish our monthly in-person meetings, and we're looking at doing that for the month of November and we will have a panel discussion.
- Zion Richardson mentioned that the panel would be focused on discussing different barriers that we face within the youth generation and, additionally, going to be providing members and viewers with ways that we cope through a lot of the different scenarios that we're facing today. So it'll be live streamed, and we're looking forward to a good turnout as well.
- We will have refreshments, and we will be sending out notices in addition to the flyers that go out each month.
- Dr. Michelle mentioned that she is working on future acitivities with Governor State on recovery issues especially, concerning our youth, and Fentanyl is one that, of course, foremost in her mind is, you know, suicide and drug abuse and the correlation, maybe between the mental health issues that she sees in her counseling practice. And that's really picking up right now.
- Any clients in Bremen Township can have access to these free workshops and open Bremen Township residents.
- Another SRC member noted the tension and concern arising around the migrant crisis and their needs.
- Yvonne reminded the group that we are more than just recovery in the sense of aiding and raising awareness
  about those with substance use issues. Recovery is about mental health and overall wellness as well, and so
  certainly you know the situation with the migrants.

- All of these contribute to mental health and stress, even from an environmental perspective, whether you're directly involved in those various situations going on across the globe they contribute to anxiety. What we call fear-raised tension is exactly why SRC is about recovery awareness in all of those aspects.
- Angelia noted that as Yvonne mentioned about the environmental issues, some of those environmental
  issues include homelessness, not having employment, not having food to put on the table. And that's why,
  with Together We Cope especially, and Cornerstone being a primary agency. The ROSC is great because we
  are a comprehensive social service agencies, and for the most part clients, can have all of the supportive
  services met in one form or another, whether it's internally at the agency or by referral.
- We'll talk more about the HUB at our December meeting. But everything that we're doing is focused on building a strong cohesive community, all the communities and making sure that any needs that individuals have are met, or their strong referrals for them to get the services that they need, which affects mental health and well-being.
- This will be our first in person meeting since Covid-19 and we want to encourage everyone to attend.
- Everyone should invite at least one person to attend so that we can have a really great meeting. And people can get some of the good information that's going to be shared during the pound discussion that's going to be led by Zion Richardson. Again, the title is "Breaking Down Barriers: self-care versus self-destruction".
- Yvonne mentioned> I think if we could just have a brief what I would call like a mini session during our
  December meeting on outreach, and what that outreach and recruitment looks like and sounds like. Similarly
  to what we talked last year in our strategic plan about having these postcards done, we will circle back to
  fulfill that action plan to provide everyone with talking points.
- Since we added on different things for this year's strategic plan, we can use the results of the Community Survey to determine gaps in services based on what the community wants/need.
- We've always had informative postcards, but we don't necessarily have where our members outside of the partner agencies, have been distributing them. So you all will be getting a stack of outreach materials at our December meeting to help you as you go about your day sharing info about the ROSC-- both in your professional arena as well as just your individual places and stops that you make. And so recovery is about just making sure that there's wellness going on amongst everyone, and to just begin to learn how to talk up on your advocacy as a volunteer member of this organization, and how people can help support us.
- We will be sending out MOUs to those that need them. I did put my name and email in the chat as well. So even though the comment says, to send me your ideas if you need to complete an MOU, which is otherwise known as a memorandum of understanding. This is just to ensure that you're aware of our partnership, and from time to time, you know, our meetings are recorded. Of course, when we do them virtually, but from time to time, when we're doing pop-ups and things of that nature as well as our conference, our in-person meetings, we will, we will take different images to help promote and spread awareness about the work that Southland Recovery coalition is doing.

- Council member mentioned> You never know who is a person with lived experience. That is not just
  necessarily a person that is in recovery right now. It's also a person that has been impacted by someone in
  recovery or struggling to get into recovery. And so I think if we just spend maybe 10 min or so just talking
  about outreach and recruitment.
- It is a requirement as part of our deliverables to the State for us to continuously recruit new members. We did bring on 2 new members this quarter. "Yay!"... but we want to continue that effort. But most importantly, to get the word out to the community in a more targeted type of manner.

#### Re: Pop Ups

• It'd be nice for us to also have materials to pass out. So that's our focus. We do have a conversation going on with Walgreens and Sock Village. So we are also waiting them to provide a date which will be in December.

The next schedule pop up is December tenth. It will actually be at American Gyro, which is across the street from Walgreens in Sauk Village and their joint parking lot with U.S. Bank. Most of our pop ups occur in the afternoon. Most likely it'll be 9 AM to 1 PM, but I am awaiting to have that confirmed, and notices will go out by mid-November for the pop up that is set for December tenth.
