Recovery and Peer Services by Devin Stieber, LCSW, CADC, ACSW, PCGC, Local Recovery Coordinator with the Captain James A Lovell Federal Health Care Center Presented on Veterans. Started with his role at the VA and his job description. SAMHSA definition of recovery, principles of recovery, (SMI) server mental illness reengagement. Each VA medical center must maintain the Local Recovery Coordinator (LRC) position first authorized in FY 2007 to help transform local VA mental health services to a recovery-oriented model of care, to sustain those changes, and to support further systemic change as new evidence becomes available on optimal delivery of recovery-oriented mental health care.
