Welcome and Introductions:

Mandy welcomed all new members.

Brief introduction of everyone attending the meeting.

Presentation by: Tessa Leach, Harm Reduction Specialist, TAT

Tessa has diverse roles within Take Action Today, she is a Community Behavioral Health Liaison, Harm Reduction Specialist, and a Peer Recovery Specialist. Her passion for this work stems from her recovery journey, which has shaped her approach and dedication to helping others. She shared a power point presentation on the importance of harm reduction within our communities and about a new initiative for overdose reversal, OneBox.

Tessa described OneBox as a practical initiative involving the distribution of purple boxes in high-traffic areas. These boxes contain instructions on how to administer Narcan, a medication used to counter opioid overdose, along with step-by-step guidance on how to assist in such situations. This program appears to be a proactive measure aimed at saving lives and addressing the opioid crisis within communities.

Chrystal Cantrell asked what helped Tessa feel comfortable taking the next step in her recovery.

- Tessa emphasized recognizing her value and finding someone who genuinely cared for her without judgment. This support played a crucial role in her journey towards overcoming challenges.

Wendy Lambert said she is very interested in the OneBox Program

Katina Miller asked if Tessa knew about a clean needle exchange in the Marion area.

- Tessa mentioned the community Action Place in Marion offers those services.

Old Business:

SIDAC 2024- Mandy initiated a discussion about the SIDAC 2024 event. The discussion was on their experiences and takeaways the attendees had. She expressed her positive experience and highlighted the satisfaction of seeing coworkers representing Take Action Today at the event.

Mandy shared an update on the Free Laundry Day event discussion from last meeting.

- Wonder Wash has a sight in Herrin and Marion for Williamson County.
- It will be estimated \$300 for each sight and we will need volunteers to help.
- Mandy asked for everyone to think about possibly volunteering and/or donating laundry detergent for the event and asked that everyone be thinking about a date and we will set the date and exact location next meeting.
