A ROSC encompasses a menu of individualized, person- centered, and strength- based services within a self- defined network.

#### Presentation by: Tessa Leech, Harm Reduction, Specialist, TAT

Tessa has diverse roles within Take Action Today, she is a Community Behavioral Health Liaison, Harm Reduction Specialist, and a peer Recovery Specialist. Her passion for this work stems from her recovery journey, which has shaped her approach and dedication to helping others.

Madison Odum inquired about the "One Box Program," which Tessa elaborated on as a pragmatic initiative involving the placement of purple boxes in high-traffic areas. These boxes are equipped with instructions for administering Narcan, a medication vital for countering opioid overdose, coupled with comprehensive step-by-step guidance on assisting in such emergencies. This program serves as a proactive approach aimed at saving lives and combating the opioid crisis within our communities.
