Purpose of the Communication and Outreach Plan:

This document outlines how the Effingham County Recovery Oriented Systems of Care Council (ROSC) will communicate the ROSC concept by educating community stakeholders on our mission, objectives, events, and other related activities. The information below includes the specific populations we intend to target and the tactical plan for various communication channels. This plan also explains the in-depth process of how the Effingham County ROSC Council will provide outreach to their community and implement the concept of ROSC.

- To show methods for communicating Effingham County ROSC Council's strategic plan including the communication/outreach plan and progress towards that plan.
- To show methods for communicating Effingham County ROSC Council's notes for monthly meetings & upcoming ROSC Council meetings & events.
- To show methods for communicating Effingham County ROSC Council's results of the community resource list and community needs assessment.
- To show methods for communicating Effingham County ROSC Council's 5 strategic plan presentations to stakeholders with defined targeted stakes, expected outcomes of presentations, member responsibilities, and measures of success.

Effingham County Identified Gaps Across the Continuum:

1. Health Promotion: Lack of community readiness to address substance use disorder (SUD) issues; Lack of awareness and understanding regarding SUD resulting in increased community stigma.

2. Prevention: EJHS is the only school receiving SUPR Prevention curriculum.

3. Intervention/Harm Reduction: Lack of knowledge/information regarding county access to harm reduction supplies and services.

4. Treatment: Lack of transportation, lack of reliable broadband access, lack of information regarding access to harm reduction programs and services including needle exchange programs. In addition, there is a lack of behavioral/mental health services and support for youth and adults.

5. Recovery Supports: Lack of recovery housing, lack of affordable treatment options, lack of peer to peer supports, lack adolescent SUD support.

The Effingham ROSC Council will continue to work with community members and providers to assist in

bridging the identified gaps across the continuum, by increasing visibility of local community resources. The ROSC Council will enhance and regularly update the community resource list.

Communication Outreach Objectives:

1.a. Continue monthly ROSC Council meetings.

- 1.b. Remain in consistent communication with ROSC Council members.
 - Send meeting minutes within 5 business days of each Council meeting.
 - Send reminder of Council meeting 1 week prior.
 - Send additional Council meeting reminder day of meeting.
 - Follow up with members via email, phone, or in-person meetings.

2.a. Hold monthly PLE committee meetings.

- Remind members of PLE Committee meeting via phone, email, Facebook chat, or in-person throughout the month.
- Post meeting minutes in FB PLE Committee page within 5 business days of each PLE Committee meeting.
- Bring ideas and suggestions of PLE Committee to ROSC Council meeting members and follow through with requests (if applicable.)
- 3.a. Continue to update Outreach Log to follow up with prior contact made with stakeholders.
 - Attend local coalition meetings, community meetings and events to identify and create relationships with possible champions of the community/stakeholder sector.
 - Consult with Council members to assist in identifying gaps in these sectors.
- 4.a. Monitor retention of community stakeholders each month.
 - Document Council member participation in the Effingham County ROSC Membership Roster.
 - Follow up with inactive members to re-engage or create new position contact.
- 4.b. Coordinate/facilitate events in which key stakeholders and people with lived experience are able to come together and discuss potential gaps/barriers in Effingham County via 1:1 interaction or sharing of PLE testimonies.
- 4.c. Coordinate/facilitate collaboration between key stakeholders within the county in order to better serve people in recovery.
- 4.d. Conduct the Hidden in Plain Sight Event and/or SUD educational presentation and/or sharing of personal stories at participating local schools.
- 5.a. Collaborate with local SUD treatment organizations/individuals.
 - Continue to build a relationship/partnership with Heartland Human Services.
 - Continue to foster relationship with Gentle Care Consultants, Grace Counseling, Wellness Loft, and Evolve Counseling.
 - Continuously identify SUD counselors in community and conduct 1:1 meetings to facilitate partnership with ROSC.

5.b. Coordinate efforts to provide MAR in Effingham County jail.

• Bring necessary MAR information in regards to education via Gentle Care Consultants and funding to Effingham County Sheriff in regards to Opioid funds proposal.

5.c. Coordinate efforts to provide transportation for recovery related events/appointments.

- Communicate with CIPT and attend transportation advisory meetings to advocate for additional transportation resources.
- Collaborate with Journey Church and Edgewood Full Gospel to provide transportation to ROSC Recovery events.
- Use PLE Committee to find rides for persons with SUD seeking treatment.

5.d. Coordinate efforts for Early Intervention educational resources to be brought into local schools- K-12.

- Perform Narcan training at Effingham Junior High School (EJHS) & Effingham High School (EHS)during health classes.
- Bring educational material to such events and available resources for school officials to access and utilize.
- Continue to reach out to local school officials to educate on ROSC concept.
- Collaborate with EHS school resource officer.

5.e. Provide information campaigns to reduce stigma and provide support to persons with substance use disorders.

- Distribute state and national information campaigns.
- Continue to implement Hour House ROSC Council Communication Campaign.
- Coordinate local resource information campaigns as needed.
- Participate in area health and wellness resource fairs and information campaigns.
- Distribute ROSC information brochures and treatment related resources.
- Collaborate with the Hour House Substance Use Prevention Program, Community Outreach and Recovery Support (CORS) Services, Circle of Care, BASE Program, Residential SUD treatment services, and Illinois Family Resource Center.
- Provide SUD related webinar and additional training information to ROSC Council members.
- Increase awareness of SUD in Effingham County during local events and "by chance" interactions.
- 5.f. Increase awareness and information for health promotion around harm reduction and services.
 - Provide information on the ROSC social media page on where/how to access harm reduction services and programs.
 - Continue to post ROSIE (Narcan Newspaper Stand) updates on Facebook from Effingham ROSC page.
 - Work with partnering agencies to share social media posts and educational materials.
 - Identify additional needs in the community to expand access to Narcan, Safe Needles, Fentanyl Test Strips, and other resources.

• Partner with the Effingham County Health Department to increase distribution and training for Narcan.

6.a. Provide stakeholders updates on harm reduction services, supplies and resource guides. Utilize Recovery Navigator education and resource information with probation clients.

- Engage and offer coordination of fundraising events for STAR.
- Partner for mandated pro-social events.
- Utilize Recovery Navigator with probation clients.

6.b. ROSC Council will provide support and education to the Effingham City Safe Passage Program and assess gaps of program if needed.

6.c. Distribute Recovery Navigator resources via resource folders and during1:1 meeting with organizations, businesses, and PLEs.

7.a. ROSC Council & PLE Committee with collaborate for ideas for sober recovery events.

- Ask PLE Committee what they'd like to see happen in their community
- Assess resources to hold such requests via Council & developed community partnerships.

Communication/Outreach Goals:

1. Share the purpose of ROSC by engaging with specific audience sectors within or serving the Effingham County community, listed below in Communication Focus- Target Audience Sectors. Note: Each specific sector's goals are listed below in Communication Goals by audience.

2. Utilize all available methods of communication; see Community Outreach Plan.

3. Ensure all deliverable items are available and up to date on the GSU website, including meeting minutes, agendas, PPTs, member protocols, community mapping results, etc. For additional information, refer to Community Outreach Plan.

4. Include ROSC Council in updating and maintaining ROSC deliverable items.

5. Confirm all Council information is current, including brochures, flyers, etc., to coincide with Community Outreach Plan.

6. Continue to maintain and engage Effingham County ROSC Council through monthly ROSC meeting

7. Utilize PLE Committee to gather real life experience and ideas for ROSC Council future goals and events.

8. Engage in 1:1 meeting with local stakeholders and community members to build SUD awareness and identify community gaps or barriers related to recovery resources.

9. Assist in building SUD awareness in the community by providing additional SUD resources, education, events, and discussion opportunities.

10. Develop additional recovery support opportunities, SUD treatment resources, local essential resources, and sober events for persons in recovery and their families.

11. Increase awareness and information for health promotion around harm

reduction and recovery services including Recovery Navigators/Peer Support Specialists in the area.

12. Hold quarterly ROSC hosted event for recovery community to promote sober,
