Agenda Item: Introductions of attendees.

Spotlight Speaker – No spotlight speaker this month.

Meeting Summary: The council discussed the community reboot event emphasizing the need for diverse attendees, including judges, officers, healthcare workers, and community members and went over part of the strategic plan which sparked several topics of conversation including the importance of early intervention programs in schools and the need for a drug court in Clark County.

Community Reboot: The Cumberland County community reboot event will take place at the CCEEBA building in Toledo at 5:00 PM. We have confirmed four PLEs who will serve as panelists. A PowerPoint presentation will be given to reintroduce the ROSC concept to stakeholders and community members. Council members are encouraged to invite five guests from their networks to attend the event.

Marketing Strategies: We will be using door-to-door mail delivery to send personalized invitations to key sectors, including law enforcement and schools. Additionally, a press release will be published in the local newspaper.

Strategic Plan: Kristina explained to the council that the strategic plan is a living document, developed based on the gap analysis identified through the community survey results. She shared her screen and reviewed several of the goals with council members. The first goal discussed in depth was advocating for the establishment of a drug court in Clark County. Sara emphasized the importance of taking immediate action rather than waiting for upcoming personnel changes. She proposed hosting a "Lunch and Learn" event at the Clark County Courthouse, in addition to the one already being planned in Cumberland County. Jenna recommended leveraging the support of Judge Baden and suggested asking him to facilitate a meeting with Judge Resch.

HRC is Developing New Curriculum: Bo informed council members that she is working with Dr Julia Wernz to develop a new SUD program with improved assessments and programming

to better benefit the clients in the community and work more productively with probation and the court system.

Brandi Rhoades: Brandi Rhoads introduced herself as a nurse practitioner currently working at a treatment center. She recently opened her own practice, *The Rhoads to Healthy*, which offers a range of services including primary and urgent care, mental health support, substance use disorder treatment and medication-assisted recovery (MAR), as well as weight loss services. ROSC Exposure: Sara emphasized the importance of consistent exposure to information in order for it to be recognized and acted upon. She suggested publishing a weekly article in the local newspaper. Brandi added to the idea by proposing that the articles highlight individuals who have successfully overcome substance use disorder and are now leading productive lives.

Subcommittee Meeting: The next subcommittee meeting will be held next Tuesday the 25th at 5 p.m. Kristina will send Brandi Rhoads an invite and encouraged anyone who wants to participate in the planning of events to send an email.
