Topic: Outreach programs

- · Key highlights:
  - Jaya shared the mission of the organization: At Rape Advocacy, Counseling, & Education Services (R.A.C.E.S.), we believe in empowering survivors, educating communities, and advocating for a world free from sexual violence.
  - RACES has been providing free confidential services for over 50 years. Their service area includes Douglas County. Serving persons as young as 3 years old and at age 17 years old the person is considered an adult not needing a guardian's permission for services. The services provided include prevention/education and response. At RACES they are a team of 20 full time and five part time staff right now.
  - Have a crisis and advocacy hotline open 24/7. The number is 217-348-4444.
  - Staff are available (24/7) to be advocates for those who are in the ER and do provide them with support, advocacy and new clothing. RACES will also provide follow up care support to anyone who has been in the ER. Staff from CU RACES can also help support the person who is supporting their loved one who is in the ER. The closest hospital to Douglas County that offers evidence collection is Carle Hospital.

- Staff at RACES help people navigate the legal system including order of protection information and this includes issues related to stalking. They are also able to connect people with any additional legal services needed.
- Please contact RACES if your school, business, or organization would like more information or would like to provide education/services to those you serve. They are happy to help and partner with anyone in Douglas County!
