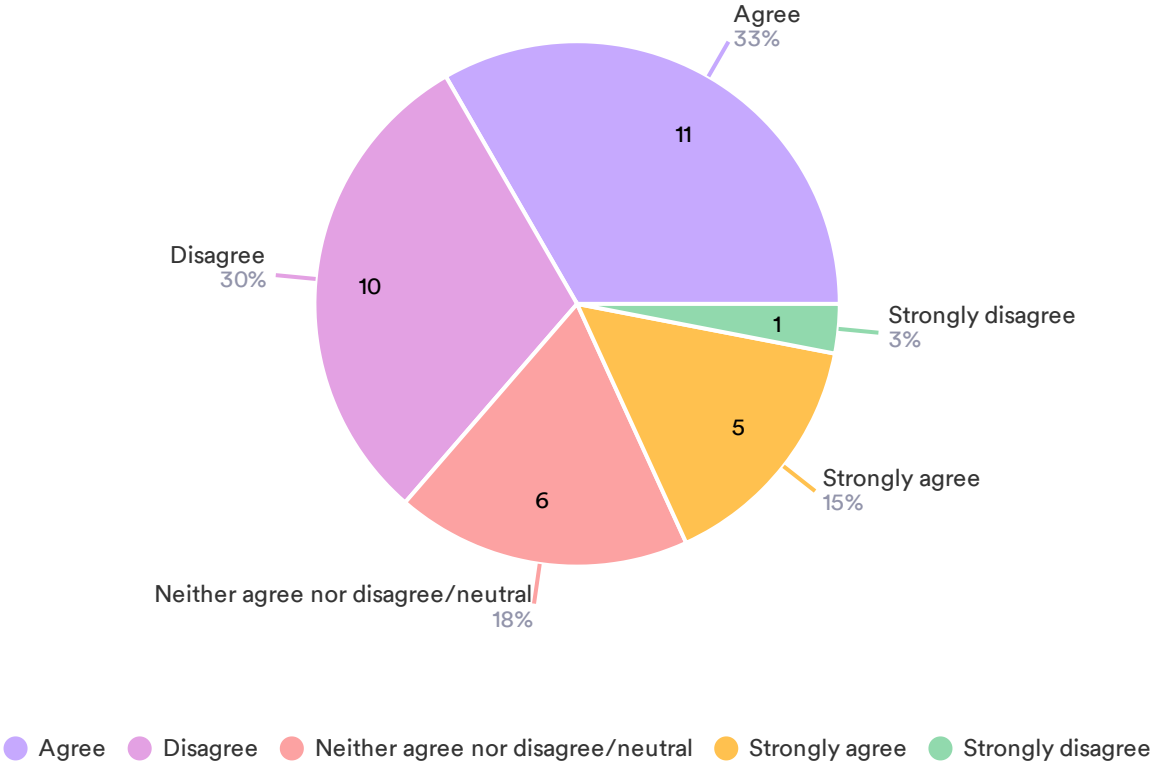

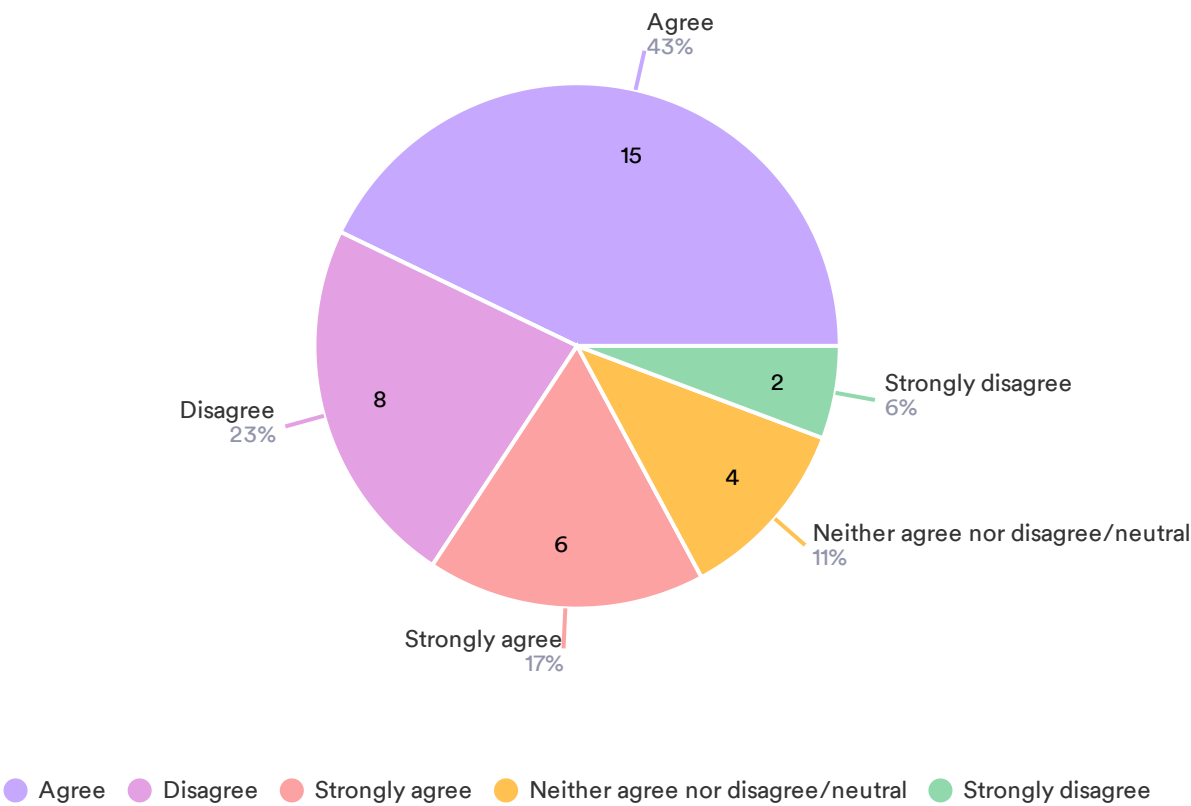

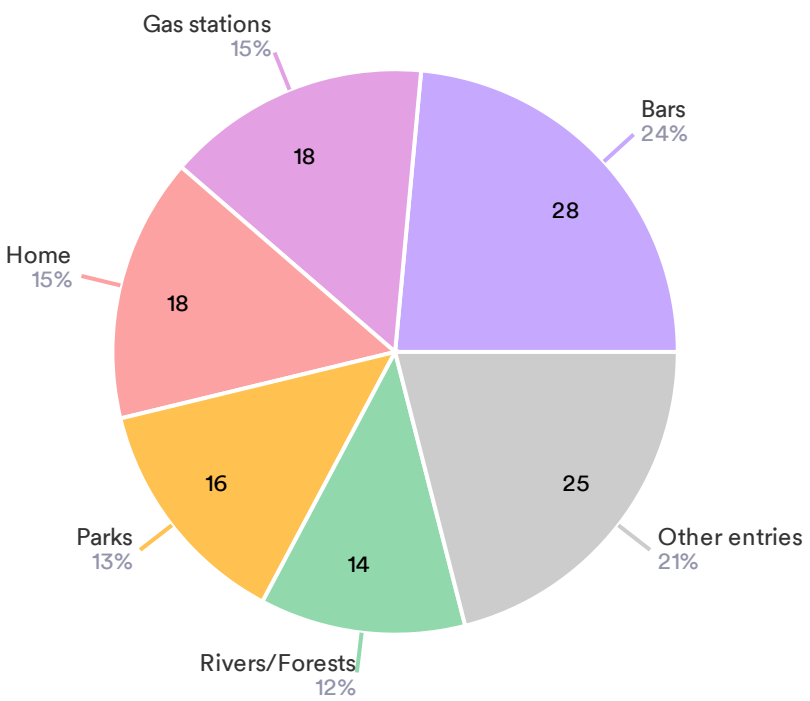
6. What specific substances are problematic in your community? (Select all that apply)

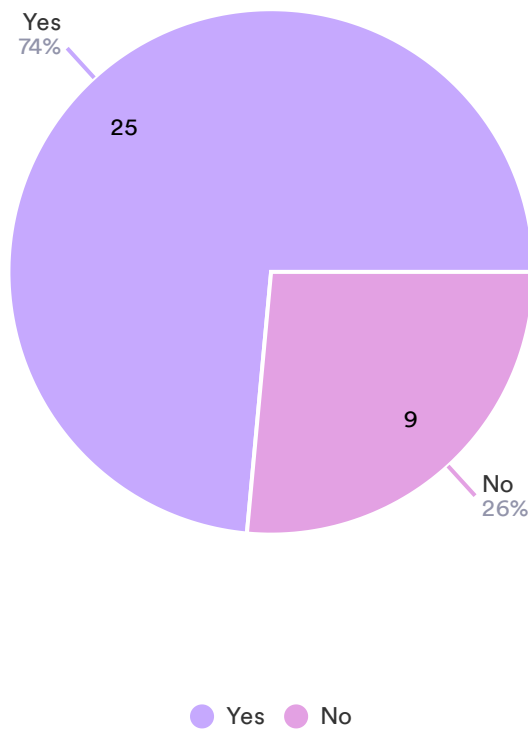
7. What places do you associate with drug use? (Select all that apply)

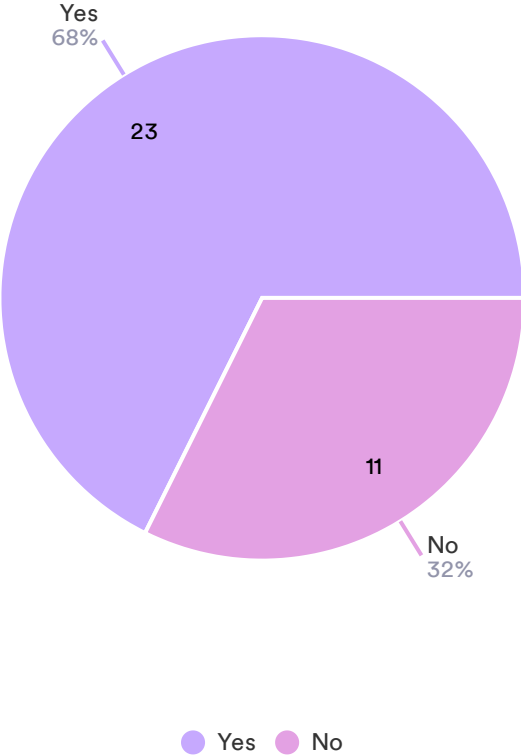
10. Have you ever been trained to administer Naloxone (Narcan)?

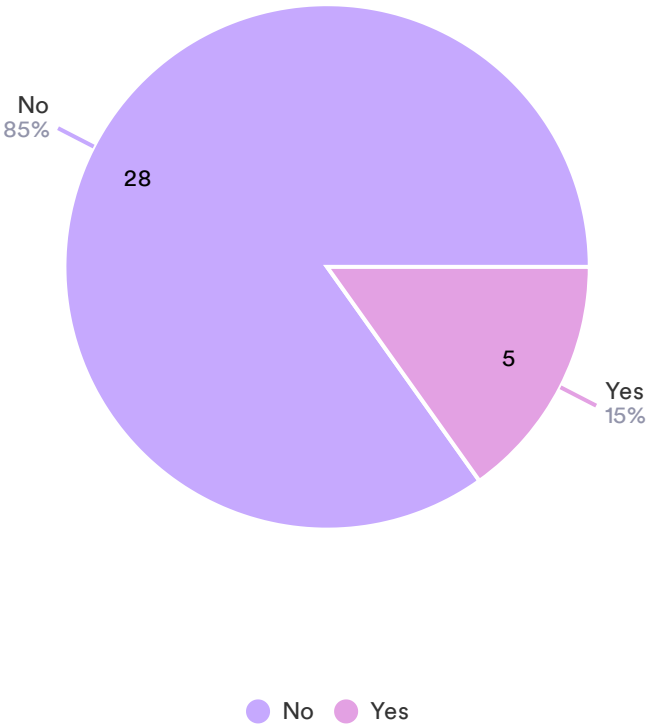

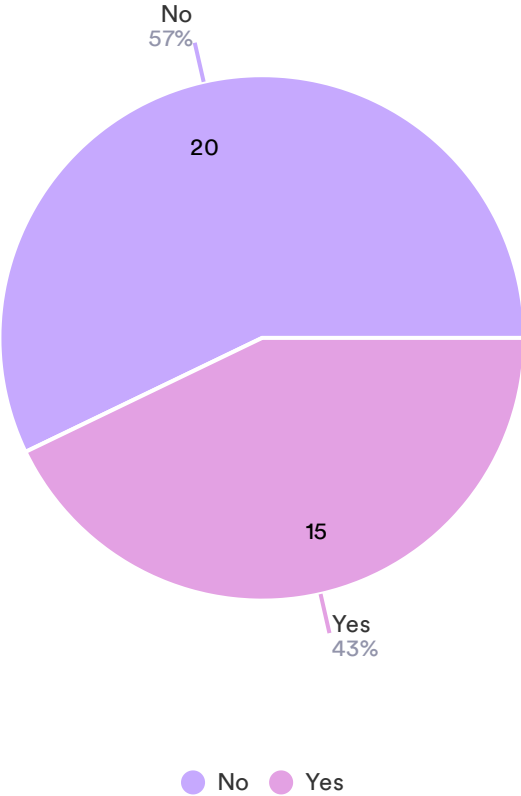
14. Are finances an obstacle for you to get treatment for substance use or mental health issues?

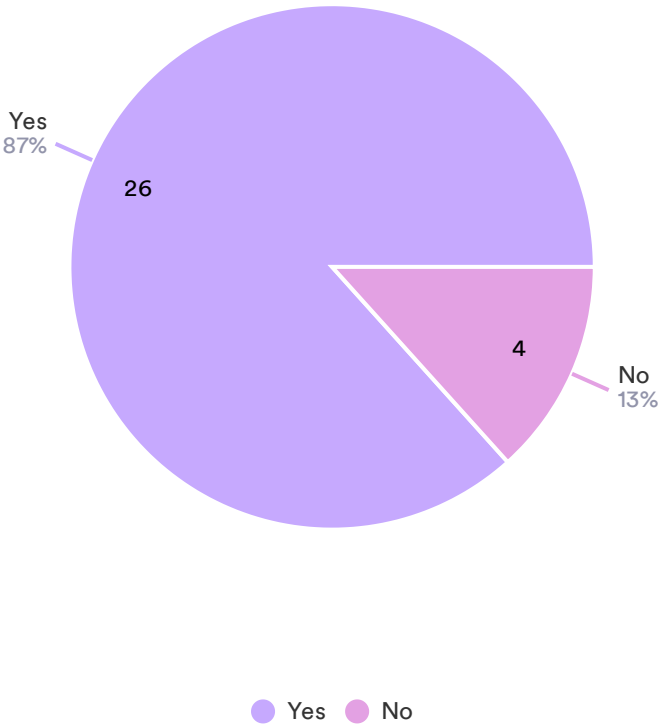
16. Have you ever utilized a food pantry?

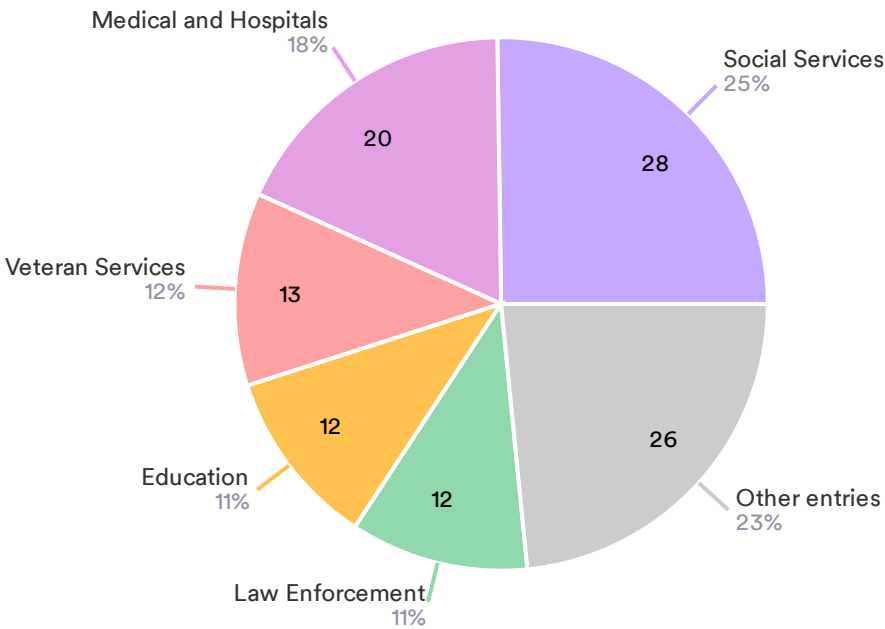
19. Do you have access to spiritual, social and cultural activities that support your recovery from substance use and/or mental health issues?

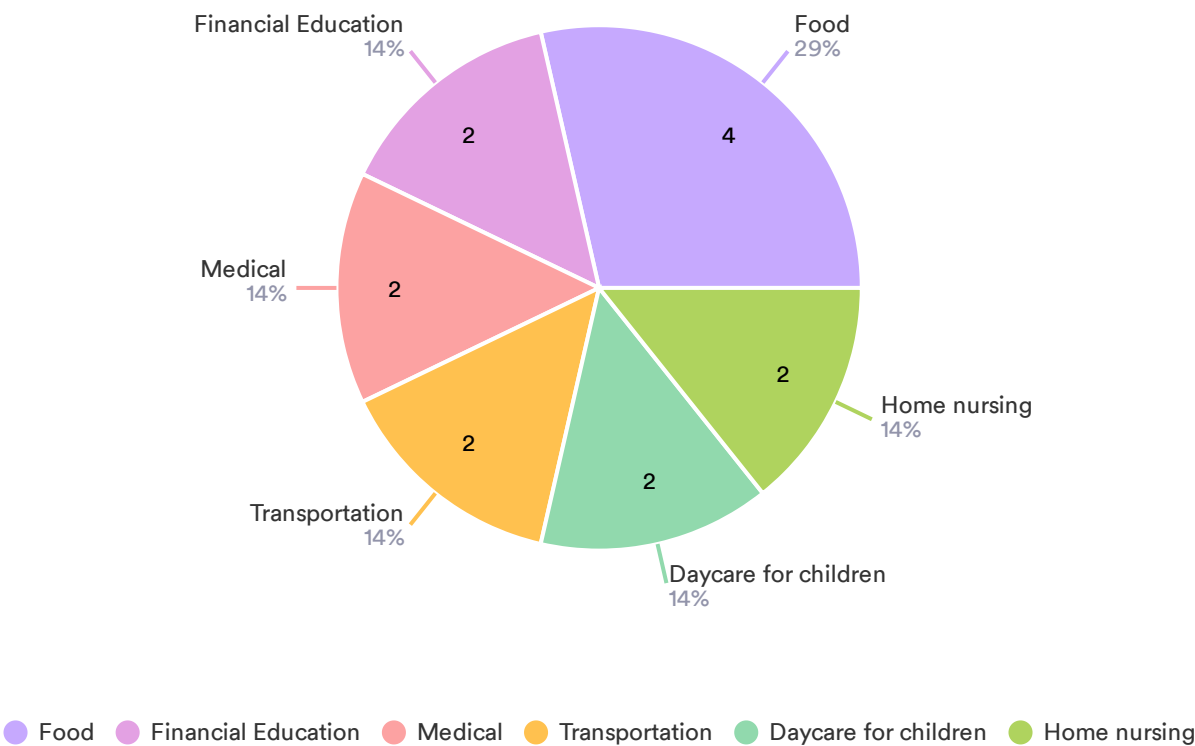
20. Do you believe that these community branches are supportive of people with substance use and/or mental health issues? (Select all that apply)
