- -Add the two together and the 6 month total is 620,321 lbs (310 tons-same as a fully loaded Boeing 747-300)

## -Drug Overdose Information

June to June numbers from the DEA

2023-107,500 7 out of 10 pills laced with fentanyl

2024-87,000 7 out of 10 pills laced with fentanyl

5 out of 10 pills laced with fentanyl

- \*One gram of fentanyl, equivalent in size to a sugar packet has the potential to kill up to 500 people.
- \*2023-47.9% of overdose deaths involved fentanyl
- \*Opioids are responsible for the largest number of overdose deaths globally

- \*Bond County has had 36 overdose deaths in the last 8 years. These range in age from 21-60 years old
- \*Bond County has also had 32 Alcohol related deaths in the last 8 years. These range in age from 18-80 years old.
