

STIGMA REDUCTION & COMMUNITY ENGAGEMENT

- Launched a 12-month anti-stigma campaign sharing recovery stories via storytelling, social media, and community outreach.
- Annual events like a recovery picnic and candlelight vigil to promote compassion.
- Recovery panels with individuals sharing lived experiences for community education and hope.
- Two "Laundry Day" events providing free laundry services and hygiene kits to 24 individuals.
- Distribution of over 130 ROSC yard signs across counties.
- A ROSC Reboot event with a recovery panel that successfully engaged Cumberland County law enforcement.

HARM REDUCTION EXPANSION

- Conducted Narcan trainings in both counties to enhance overdose response.
- Collaborated with Cumberland County Health Department for EMS and firefighter training.
- Secured Opioid Relief Funds from Clark County Board for harm reduction efforts
- Installed a Narcan Vending Machine at HRC in Marshall, with reports of lives saved.

ADVOCACY FOR SYSTEMS CHANGE: DRUG COURT DEVELOPMENT & DIVERSION PROGRAMS

- Advocated for a Drug Court in Clark County to promote treatment over incarceration.
- Engaged the community through events like the Drug Court Panel.
- Secured support from the Clark County Sheriff for judicial alternatives for substance use disorder.
- Plans to establish a quarterly subcommittee for developing a Drug Court action plan.
- Hosted a Lunch & Learn at the Cumberland County Courthouse to discuss a Diversion Program with key stakeholders.
- Cumberland County is actively implementing a Diversion Program due to stakeholder collaboration.

SUPPORTING TREATMENT, RECOVERY & JUSTICE INVOLVED POPULATIONS

- Secured Opioid Settlement Funds from the Cumberland County Board.
- Opioid Funds were used to hire a part-time Recovery Navigator to assist those in treatment and early recovery.
- Distributed recovery literature purchased with opioid funds to raise community awareness and provide guidance.
- Aided justice-involved individuals with cell phones, phone cards, homeless backpacks, and gas gift cards, all purchased with opioid funds.
- ROSC Recovery Navigator conducts educational groups at Clark County Jail offering support and information to justice-involved individuals.
- ROSC Recovery Navigator conducts educational groups at Clark County Probation and at Cumberland County Probation.
