Spotlight speaker – No spotlight speaker this month

Meeting Summary: The meeting opened with updates on social media outreach and communication campaign efforts, dates for upcoming events such as the recovery picnic and candlelight vigil. The council reviewed their fiscal year impact report, emphasizing progress in Narcan distribution and training, as well as key events and accomplishments throughout the year. The discussion concluded with planning for the upcoming fiscal year, focusing on strengthening partnerships with the justice system, law enforcement, and veteran services, while also developing strategies to reengage schools and other community sectors.

Clark/Cumberland County Facebook Page: Kristina discussed the progress on their Facebook page, which now has 652 followers and 293 likes.

Communication Campaign: We wrapped up the last month of the fiscal year's anti-stigma campaign with a recap reel and a press release including all the topics that were covered.

Narcan Distribution and Training Impact: Council members reviewed their fiscal year impact report, highlighting their work with Narcan distribution and training. They noted that 444 boxes of Narcan were distributed between Clark and Cumberland counties, with 30 peace meal drivers trained. The team agreed that their work with the court system was their biggest impact, though they also made progress in establishing new Narcan distribution sites, including one at Moe's Liquor store in Marshall.

FY25 Community Events: The council viewed a visual presentation highlighting key events and initiatives from the past fiscal year. The presentation showcased the wide range of activities organized by the council, including educational panels, community outreach efforts, recovery celebrations, and harm reduction initiatives. It served as a reflection of the council's ongoing commitment to supporting individuals in recovery and building a more informed, compassionate community.

Deliverables/Impact Report: The team reviewed a one-page summary highlighting key accomplishments and events from the past fiscal year. They reflected on a range of impactful activities, including Narcan distribution, a candlelight vigil, a recovery picnic, a community bowling event, and the Cumberland County ROSC Reboot. The team recognized the successful use of opioid relief funds in Clark County to purchase a Narcan vending machine, which has already been credited with saving a life. Additional highlights included the launch of a 12-month anti-stigma campaign, the distribution of over 130 ROSC “Recovery is Possible” yard signs, and the hosting of two Laundry Day outreach events. The council also secured opioid funds in Cumberland County to support recovery initiatives, which enabled the hiring of a part-time recovery navigator to assist individuals in treatment and early recovery. Support for justice-involved individuals was expanded through the distribution of cell phones, phone cards, homeless backpacks, and gas gift cards—removing barriers and helping participants stay connected to vital services.

Strengthening County Justice Collaborations: The council focused on planning for the next fiscal year, with discussions centered on expanding collaborations and strengthening connections with local justice systems and first responders in Clark County. Heather suggested engaging with dispatchers, regional education offices, and veteran support networks, while Kyle highlighted the importance of face-to-face meetings with law enforcement to foster better engagement.
