 - a. Substance Use Disorder: Approximately 40-60% of individuals treated for substance use disorders relapse at least once; Over 93% of people with a past-year substance use disorder did not receive specialty treatment
 - **b. Mental Health Disorder:** More than one in five U.S. adults live with a mental illness, which equates to about 59.3 million people in 2022; Serious mental illness affects 5.5% of U.S. adults

c. Addictive Compulsive Disorders – problem gambling: Problem gambling affects about 1.29% of the adult population.

IV. Presentation: Problem Gambling, Healthcare Alternative Systems

Tiffany Webb and Angel Pabon presented on Problem Gambling. Key points included the prevalence of substance use disorders, with 40-60% relapse rates and 93% lacking specialty treatment. Problem gambling affects 1.29% of adults, often co-occurring with other addictions and mental health issues. Strategies for addressing gambling problems include non-judgmental communication, community awareness, and linking individuals to resources like the 1-800 Gambler helpline. The meeting also highlighted the importance of faith-based training and job opportunities for youth at risk.
