Opening Remarks:

Ben Rudolf opened the meeting with a unifying prayer, blending a traditional Jewish blessing— "Baruch atah, Adonai, Eloheinu, melech ha'olam"—asking the Creator of the Universe to guide and protect us, with a reflection on the Lord's Prayer, focusing on: "Lead us not into temptation, but deliver us from evil."

He emphasized that both prayers ask for divine guidance and protection, reminding us:

"Alone, we will fail. But if we work together, we will prevail."

He closed by dedicating the meeting to God, praying for unity, collaboration, and hope in addressing mental health and substance use challenges.

Introductions & Welcome

HeartLife Ministries – Will/Grundy County R.O.S.C. Council Meeting

Tarcia warmly welcomed everyone and transitioned into introductions by inviting first-time attendees to briefly share who they are and where they're from.

Guest Speaker Introduction:

Dana Fedenia from OPVEE

Dana was invited to present on the topic of OPVEE, a recovery medication option.Tarcia acknowledged that the topic may spark varying perspectives and encouraged everyone to listen with openness. Following Dana's presentation, there would be time for questions and discussion.

Presentation by Dana Fedenia:

- Dana introduced herself and Alonzo Whyte from the medical team, then explained that the presentation would focus on OPVEE a nasal spray opioid overdose rescue medication designed specifically for synthetic opioids like fentanyl.
- Unlike Narcan, which uses naloxone, OPVEE contains nalmefene, offering faster and longer-lasting effects. In studies, it restored breathing in about 2.5 minutes and maintained effectiveness for over 11 hours, addressing the high potency and long duration of synthetic opioids.
- OPVEE is currently being used by first responders in select areas like Will County, IL, and Oakland County, MI. It's easy to administer, has a 3-year shelf life, and offers a vital tool in combating today's opioid overdose crisis.

Questions and Discussion

- Is this available for nonprofits or free? It's available statewide but not free yet. We're working on grants—currently costs about \$75 a box.
- Can Narcan and Opvee be used together safely? Yes, both can be used with no safety issues. Use whatever is available to save a life.
- Was the study independent or replicated? Yes, an independent group conducted it, and other studies show similar positive results.
- Can this medication be given if unsure about an overdose? Yes, like Narcan, it's safe to give if someone isn't breathing, unless there's an allergy.
- How widely is it used?

Used by several agencies in Illinois with multiple successful reversals; growing nationwide.

• Important: Always call emergency services after giving any overdose medication.

Welcome and Introduction of Magdalena Campos
