### **Key Approvals**

- Without objection, the meeting minutes from June were approved

Support groups, upcoming events, and ROSC member updates.

- **The Health Department**- is now hosting AA meetings every Thursday at 2:00 PM
- **Bowling For Recovery** - is being held at the Winchester Bowling Alley from 1PM-3PM July 18<sup>th</sup>
- **The Crisis Center Foundation**- shared discussion about Healthy Relations starts in July
- **TASC**- Shared that Blackburn College will be hosting a block party date hasn't been decided on yet.

Addressing social determinants of health for substance use recovery.

- Discussions highlighted the importance of addressing social needs, such as access to clean clothes, to help individuals in recovery connect with resources and achieve their goals. Thanks to a coordinated effort between every member of the ROSC, much of our work has been centered on this over the past year and a half. This must

continue as this is making a difference in people's lives. It also supports each of our service delivery areas of the various members, bringing coordination to our recovery-oriented system of care. We are helping people get jobs, getting them access to educational resources, finding medical care, accessing health and wellness supports, helping get laundry, finding clothes, identifying resources to support social needs, getting legal support, and so much more.

### **New Initiatives and Updates:**

Discussions also focused on navigating legal challenges faced by individuals in recovery and identifying local, community-based resources for ongoing support. These efforts are already making a meaningful impact and directly reflect the shared mission of our ROSC: to build a comprehensive, person-centered recovery network.

Greene County Health Department got Overdose Response Grant.

### **Supply Closet & Donations:**

The ongoing need for donations to stock our supply closet was emphasized. This resource remains essential to breaking down everyday barriers that hinder recovery by ensuring individuals have access to basic hygiene and personal care items.

### **Additional Council Actions and Discussions:**

- Initial planning is underway for interagency meetings in both Greene and Scott Counties. These meetings are designed to enhance cross-sector collaboration and improve coordination of services among agencies.
- A standing monthly ROSC Council Planning Committee meeting will be held at the beginning of each month to coordinate activities, set priorities, and strengthen the overall impact of ROSC initiatives.

### **Member Updates:**

- Just as a reminder, there is a Member Orientation on the 3<sup>rd</sup> Wednesday of every month where new members can join to learn about ROSC, our work and the direction of our council
