Business: A recap of FY 25

MERC has held 18 Stigma conversations in the community, MERC has had 12 community engagement opportunities via Health fairs and community events, we have created 3 different family recovery events with the help of AMARE where we were able to provide a free screening of a several family friendly movies at the Church of Nazarene in Roxanna IL, we have helped sponsor AMARE's Rockin 4 Recovery event every Sept for the past 5 years, we have helped distribute 125 NARCAN Emergency bags, connected resource information for SUD and Mental health services.

MERC along with the help of all of you in the council (we passed out over 350 physical surveys), completed a community survey to help us find where we are in need of more services and how MERC can help in connecting people with the services. The survey held in Madison and St. Clair County to help in our community needs assessment which became a part of our Strategic plan for fiscal yr 2026.
