I. Welcome & Attendance

a. Barb Brumleve welcomed everyone and asked that any new attendees introduce themselves and all to drop their name and agency affiliation in the chat for recording attendance.

II. Agency Spotlight: Colleen O'Connor, Project Oz Caregiver Survey & Nami Mid Central Illinois

- a. Colleen O'Connor presented information about a caregiver survey from Project Oz and highlighted NAMI Mid-Central Illinois's efforts in youth mental health education. The survey seeks input from parents and caregivers to determine the most helpful topics and formats for educational presentations. O'Connor emphasized the importance of engaging families in mental health discussions to foster supportive environments for youth.

 - ii. Collaboration opportunities with local organizations and stakeholders.
- b. NAMI Support Groups and Resources
 - i. Colleen O'Connnor discussed the activities of the local NAMI chapter, including monthly support groups for individuals facing mental health challenges and their loved ones. These groups, held at West Olive Faith United Methodist Church, are peer-led and free of charge. Additionally, Colleen mentioned upcoming classes aimed at educating family members on how to support their loved ones.

 - i. As a result of our work for gauging stigma in the community during implementation of our community survey, we were able to partner with the local newspaper to have an article run promoting our community survey and the efforts of the McLean County Recovery-Oriented System of Care.




- ii. As a result of our stigma reduction efforts in the beginning of FY25, we were able to educate a local Rotary club on best practices for substance use prevention initiatives.
- iii. As a result of our outreach efforts during National Recovery Month 2024, we were able to have impactful conversations regarding lived experience with five different individuals and provide resources for them.

g. Strategic Goal 2: Promote Harm Reduction

- As a result of our Narcan distribution efforts within McLean County, we were able to distribute over 340 individual boxes of Narcan over the course of FY25.
- ii. As a result of our work in promoting harm reduction within McLean County, we were able to connect with God's Mission Ministries, a local community member-run organization that focuses on distributing harm reduction supplies such as clean needles and syringes.

h. Strategic Goal 3: Increase Service Delivery

- As a result of working to ensure effective service delivery within McLean County, we strengthened our collaboration with A New Horizon Recovery Community Center through two new initiatives in FY25.
- ii. As a result of our networking efforts, we engaged with and established a relationship with a completely new community stakeholder, Allies Against Trafficking, a local human trafficking nonprofit organization.
- iii. As a result of our efforts in engaging with people with lived or living experience, we increased our planning committee by 4 new members.





IV. National Recovery Month September 2025

a. 3rd Annual Recovery Month Library Book Displays

i. McLean ROSC & A New Horizon Recovery Community Center are partnering again this year to collaborate with libraries across McLean County for the third annual Recovery Month Library Book Display initiative. Libraries will display anti-stigma campaign materials along with harm reduction resources and recoveryoriented book titles.


b. Recovery Stories Project


c. Paint the Town Purple Initiative


