### **Spotlight Speaker**

**Natalie Inman-** Shelby County Community Services

Shelby County Community Services (SCCS), based in Shelbyville, Illinois, provides Level One outpatient substance abuse treatment for both adults and adolescents. Under the leadership of Natalie Inman, program coordinator for six years and an employee for nine, SCCS offers individualized treatment plans to support clients in achieving healthy, recovery-based lifestyles. Located conveniently near the courthouse and jail, the facility operates Monday through Friday, offering extended hours to accommodate clients' work and family commitments. SCCS merged with a mental health facility to become a behavioral health unit, allowing for better coordination of care, especially in complex cases involving mental health and substance abuse.

The clinic offers up to nine hours of weekly treatment, including both group and individual counseling. The staff is experienced and consistent, with team members like Lila (office manager), Alicia (counselor and drug court case manager), and Heather (counselor) providing continuity and quality care. SCCS is also an active partner in the Shelby County Drug Court team, aiding in the rehabilitation of justice-involved individuals. Clients may be self-referred or referred by entities like DCFS or the criminal justice system. The clinic maintains regular

communication with referring agencies and accepts all Illinois Medicaid plans, some commercial insurance, and offers sliding scale options for payment.

In addition to treatment services, SCCS provides comprehensive DUI services—including consultations, evaluations, risk education, and assistance with Secretary of State hearings. The center also supports clients through case management and community intervention, addressing broader needs like housing, childcare, and access to basic living essentials. SCCS offers early intervention strategies for at-risk youth and toxicology services for individuals, employers, schools, and agencies like DCFS. Overall, SCCS takes a holistic, accessible approach to substance abuse treatment, mental health care, and community support.

## **FY26**

Skylar let the council know that Moultrie and Shelby County will become independent councils, with their first meetings scheduled for August. Skylar will remain involved with both councils and assist in the training and transition of a new Shelby County coordinator. Additionally, a navigator will be shared between Shelby and Effingham counties, while Moultrie will collaborate with Douglas County.

Jenna detailed the decision to split counties for grant applications, which was necessary to maximize funding due to state restrictions. Each county received the same funding as the previous year, ensuring staff continuity. Skylar acknowledged the positive outcome and emphasized the need for effective coordination of meetings in light of the changes.

Skylar will be sending out a poll for times/dates that work best for the separation of the monthly council meetings. It was also discussed that not everyone needs to remain on the email list if they would prefer one county or both that can be done!

## **Drug Overdose Prevention Program**

There has been a new DOPP site established at the Lovington Laundromat. Skylar checked DOPP sites to make sure that they were stocked while she is on medical leave and is also going to provide contact information for anyone who may need harm reduction materials in her absence. Skylar lightly touched on goals for DOPP sites as the counties split.
