Recovery Oriented Systems of Care (ROSC) Community Survey

<u>PURPOSE</u>: This survey is to gauge the level of awareness of all available resources in Clark County and measure public opinion on issues related to recovery. The information collected will be used to identify areas for improvement in our community and will remain confidential.

<u>DEFINITIONS</u>: The terms listed below are used throughout the survey and are provided to ensure people provide the best educated answer.

CPRS- Certified Peer Recovery Specialist (CPRS) — a trained peer with lived experience of substance use disorder or mental health recovery who provides support, advocacy, mentoring, and resource navigation to others.

Drug Court- a specialized court program that provides individuals with substance use disorders an alternative to traditional incarceration. Instead of serving jail time, eligible participants are connected to treatment, counseling, case management, and ongoing supervision. Drug Courts aim to reduce recidivism, support recovery, and improve public safety by addressing the root causes of addiction through accountability and support.

Drug Overdose Prevention Program (DOPP) Site- designated location in the community—such as a business, library, or community center—that hosts a public Narcan display. These sites provide free access to Narcan (naloxone), a life-saving medication that reverses opioid overdoses. Community members can take Narcan from these sites at any time, with no questions asked and no requirements to provide personal information.

Harm Reduction- evidence based strategies that aim to minimize the negative consequences associated with substances use, prevent overdose & infectious disease transmission, improve over-all wellbeing, & provide low-barrier access to healthcare services.

Recovery- a process of change through which people improve their health and wellness, live self-directed lives, and strive to reach their full potential.

Recovery/Transitional Housing- Recovery or transitional housing is a safe place to live for people who are working to overcome drug or alcohol problems. These homes are alcohol- and drug-free. People living there support each other, follow house rules, and may get help finding jobs, going to school, or moving into their own place. It's a stepping stone between treatment

Substance Use Disorder- another phrase used for addiction to drugs or alcohol; a complex medical condition characterized by uncontrollable patterns of substances despite harmful consequences.

Syringe Program- A syringe program is a community-based service that provides people who use drugs with clean, sterile needles and a safe way to dispose of used ones. These programs are designed to prevent the spread of diseases like HIV and Hepatitis C, reduce the harms associated with drug use, and protect the health of both individuals and the community.
