II. Agency Spotlight: Harm Reduction Efforts in McLean County – God's Mission Ministries, Kim Massey

- a. Kim Massey shared that God's Mission Ministry is a street outreach program in Bloomington/Normal. They are a 501c3 in the state of Illinois and by the federal government. God Mission Ministry will have its four-year anniversary in March! They provide all kinds of outdoor living supplies, everything from tents, tarps, sleeping bags, blankets, and over 30 hygiene items are available. They recently launched a laundry program on Tuesdays for their clients to be able to come in and do their laundry. Outreach services are on Wednesdays, and a hot meal is provided on Sunday's (winter they are delivered). Additionally in the winter months propane heaters, hats, gloves, hand warmers and undergarments are also provided. Kim shared that she was certified by Jolt Harm Reduction in Peoria a year ago in harm reduction/Narcan® trained. During outreach they always carry a bag with different types of harm reduction:
 - i. Narcan®
 - ii. Test strips
 - iii. Kits with Saline, tourniquet, alcohol pads, sanitizer
 - iv. Anything else provided by JOLT
 - v. Exchange boxes
 - vi. Resources
- b. Kim hopes to help save lives by meeting people where they are as you cannot recover if you are not alive. Please reach out to Kim with any questions or additional resources she might be able to share.



- Tory Dahmm from Medmark for the methadone treatment center in Normal would love to have Kim's cards available for her clients. Tory also noted that maybe they could consider some comfort meds that would help with withdrawal symptoms like Imodium and Emesis bags.
- ii. Shayla Woodworth asked about other harm reduction supplies such as cookers, straws, etc. Kim stated they have do have cookers available. Shayla also inquired about becoming certified. Kim said Jolt certified her but not sure if this is something they are still doing. She stated there is a lot of information at nationalharmreduction.com
