3) What is ROSC?

Rick Zehr explained the Recovery Oriented System of Care. Our ROSC is more urban than many of the other councils that are more rural. ROSC gives feedback, adviceacts as the communicator with the State.

4) Stakeholders

Rick Zehr noted we have a diverse set of stakeholders to promote ROSC across the entire community. We are a dominant provider of substance abuse services not just

in Peoria but Lincoln, East Peoria, West to Galesburg as far as Quincy. We are not just limited to Peoria. All the stakeholders are not here but we are seeking ideas for additional Council members. We are seeking input from policy makers, folks with lived experiences, and people from the prevention side.

Kami added that those groups mentioned so far are important but reminded the group to not just include the folks we encounter in our professional life but personal life as well. Include the faith-based sector. Other ROSC groups struggle with getting input from this group.

Regarding the question of how many faith-based individuals are too many. Kami mentioned that we should look for diversity in this group. For example, not all clergy, not all parishioners, etc.

Rick Zehr mentioned that he has a possible lead for this sector.

Names of various individuals and organizations were mentioned as possible stakeholders/council members.

Judge Doscotch is a friend of Edie. Denise has a meeting with him next Friday.

Angel Cruz in the Drug Court was recommended as a council member as well as someone who represents Jolt.

Jim Shadid-President of Bradley University. Edie will help.

Jehan Gordon-Booth- Derrick Booth's wife. Rick Zehr reports to Derrick so will reach out to Derrick.

Librarians- are familiar with the individuals who need assistance. Sue Tisdale knows librarians.

Rob Harlan and Kevin Hardesty with Peoria Intergroup Association.

Kami mentioned that we tend to be Peoria-centric, so we need representation from across the region.

 - iv. Equitable access to care

Kami advised that we could change priorities once selected. This is a living document we can make changes. According to Kami, we are off to a great start. We need to identify our priorities. She shared what other councils are doing.
