- What is a criminal record?
- What rights do I have if I have a criminal record?
- What is Records Relief, and why should I pursue it?
- How do I start the Records Relief process?
- A record of involvement with the criminal-legal system, including arrest without conviction
- Exists in many places
- Often inaccurate
- It can limit access to housing, employment, education, and opportunity. Limits called "permanent punishments"
- There are nearly 1,200 permanent punishments in Illinois.
- 1 IN 3 Americans has a criminal record.
- WHAT RIGHTS DO I HAVE IF I HAVE A RECORD? Voting, Housing, Employment. If your rights are violated, you can take action.
- WHAT IS RECORDS RELIEF? Sealing or expungement* Healthcare Worker Waiver Certificate of Good Conduct Clemency
- WHO IS ELIGIBLE? AND WHEN? Only four types of offenses are ineligible: DUI and reckless driving,
 Violent Offenses, Domestic battery, & Violation of protection orders, & Sex crimes (except prostitution and misdemeanor public indecency)

WHAT IS SEALING AND EXPUNGEMENT? Expungement: records deleted. Sealing: records hidden from
the public, visible to law enforcement, and some employers. Rule of thumb: visible to employers who require
fingerprint-based background checks. If your record is expunged or sealed, you can answer no when asked
if you have a criminal record
