The August meeting for Bridgeway's West Central Illinois ROSC was a huge success. We had a large group of 34 people in attendance. We had over 14 different agencies represented from many different sectors. Agencies represented included Bridgeway, Chestnut Health Systems, Oxford House, Goodwill Foundation, Knox County Health Department, WIRC, AHEC, Knox County Drug Court, Hope Outreach, ARCH and more. We were able to introduce and hear from Marty McNamara, Bridgeway's newest CPRS. We were also introduced and heard from Pat Hall, the new Knox County Drug Court probation officer. WCI ROSC Coordinator enlisted the help of council to help put together the remaining questions for our survey. A discussion and suggestion forum followed on ways to increase survey participation. WCI ROSC promoted the 5th annual overdose awareness candlelight vigil on August 31st. Also announced and promoted was the September 20th "Stand Up For Recovery" event in Peoria, Illinois. West Central Illinois ROSC coordinator has met with council members, Bridgeway staff and superiors to discuss the survey, strategic plan and direction of the WCI ROSC Council.
