III. Speaker - Vawnshekia Oklah

- The greatest asset in life is your brain and thoughts. What you think about can change your perception of life.
- Addiction Recovery doesn't look the same for any individual ROSC wants to acknowledge individuals giving support in the community and make them feel accepted.
- We are determined to make sure the world we create is the world we can recover together as a community.
- Addiction affects the community as a whole, your family and friends and peers around you. The community
 as a collective is affected.
- Recovery is celebrated,
- Addressing how to build a system that uplift one another.
- Rainbow Push Correlation (Jessie Jackson I Am Somebody).
- Substance abuse challenges the black community heavily and other minority communities...
- Embracing the support for recovery!
- Personal growth.

- Statistics show the southside of Chicago has a high rate of substance use challenges.
- African Americans have a higher drug use than other cultures.
- Statistics show 73% Male and 26% Female for drug abuse.
- Statistics, alcohol and fentanyl are most used.
- Statistics Fentanyl abuse for the Black population is at 950 white population 421 latino population 256.
- Training on NARCAN.
- People need to know you, understand you, support you and uplift you!
- Encouraging employers to hire those with a background.

V. QUESTION AND ANSWER SESSION— Vawnshekia Oklah

- What are the obstacles and improvements needed in the community? Inequality & discrimination barriers due to race, gender, socioeconomic status, or disability often affect access to resources and representation.
- B Goals: Building a support network of services of those seeking jobs. Why is this important? This is
 important because it is hard to find a job in the community with any background. Judgment of skin,
 appearance is an issue.
- What are the obstacles to employment once you have a background? Some obstacles are lack of
 experience, Increases stigma in employment. Being too assertive or aggressive. Many employers are
 hesitant to hire individuals with a criminal record due to concerns about trustworthiness, safety, and
 potential liability. Studies show that the stigma of a criminal record alone is a significant reason employers
 avoid these applicants.

Obstacles and Solutions

- Judgment Stereotypes ~ Change appearance and training in day to day work.
- Charges ~ Check if eligible to clear or seal criminal records. Reentry Programs: Join programs that connect people with records to job opportunities such as Second Chance programs, nonprofits like The Doe Fund, or local workforce development centers.
- Self Esteem ~ Therapy or peer support can help rebuild self-worth.
- Computer Skills ~ Websites like GCFGlobal, Coursera, or YouTube provide beginner-friendly tutorials.
- Confidence ~ Practice with a friend, mentor, or workforce coach.
- Background ~ Gaining experience through internships, apprenticeships, or volunteering can build up a resume. Filling educational gaps can open more doors.
