We have 4 different locations for youth and adults, which has made things easier and better for those looking for a safe place to go. We look forward to more people coming and celebrating big and small victories. We have two sobriety birthdays coming up. One young lady will have 5 years and a gentleman will have 2 years.**

It made such an impact and brought people together instead of dividing them. Some of the council had some ideas to help improve or make changes for next year.
