#### Spotlight Speaker - Brycen McFadden, Oxford House

**Brycen**, an Outreach Worker for Oxford House Inc., provided the council with comprehensive information about the program, including its key principles, origins, qualifications, structure, and current statistics. Oxford House offers individuals with substance use disorders (SUD) from all backgrounds an increased opportunity for long-term recovery through its peer-supported, sober living model. The program is particularly effective for individuals with a history of opioid abuse, co-occurring SUD and mental health disorders, veterans, drug court participants, those re-entering society from incarceration, and individuals with a pattern of chronic relapse. #### **Homelessness Awareness Month**

#### **Laundry Day Update**

**Skylar** reviewed next steps for Free Laundry Day in Coles County. She explained the work she has done in other counties with Laundry Day and expressed her excitement with this event. **Lisa** introduced Skylar to Dial-A-Ride Program Director, **Kaycie Sanders**. They discussed providing transportation to members of the community for the laundry day. We are aware that we would need to work around their schedule to be able to have this partnership. **Stephanie** confirmed during the meeting that **Kaycie** would touch base with her soon and then they would reach out about what works best. Skylar asked where the last laundry day took place and **Jenna** said it was in July in Charleston. **Skylar** stated that we would have the next one in Mattoon. She also mentioned that there is \$150 available for the event but more funds are needed.

## **Survey Updates**

**Skylar** reviewed survey outreach and numbers with the council. So far, Coles County has 130 community survey responses. To hit our 5% goal, we need a total of 2,500 responses.

Outreach we've done so far:

**Skylar** passed QR codes at the Coles County Business Expo, shared it at CIL-CON event, sent to multiple to friends throughout Coles, asked men and women's residential facilities to fill them out, sent to all Hour House staff, put QR codes out on tables at Phoenix Elite, took to Stepping Stones daycare for staff and parents, asked people to fill it out at the Recovery is Real Celebration.

**Megan** has taken QR codes to multiple businesses, such as, Coca-Cola, Owens Motorsports, and KC Summers. She plans to take paper copies when she attends her church and CR. She's shared with multiple of her personal contacts.

**Skylar** and **Megan** both will continue to share the survey and work together to outreach and get some solid numbers.

**Jenna** suggested that we go to the JAC for a ½ day and ask customers to fill it out while they wait on their order.

### **Recovery Navigator Update**

**Megan Ballard** is the new recovery navigator for Coles County ROSC. She will be spending part of her time in Shelby County. She shared with us that she graduated Coles County Drug Court in May, and she is really grateful for Hour House and Drug Court because without their structure and support she wouldn't be in the position she is in today. She shared about her start date and how training has been so far. She has done a lot of work on the survey outreach and with DOPP sites already.

### **Open Discussion or Updates**

**Linda Scriber** mentioned PJ's Place, a sober-living home that will be opening in Douglas County. She told anyone who has not seen it yet to come check it out. **Gary** wants to connect with Linda about sober-living.
