Agency Updates

Nathan- gave a brief summary of CIPT.

Patrick- working with Dawn a little bit on hosting some trainings in the Sullivan area, for the faith-based communities and as that comes together, he will share more.

Dawn- listed free services Family Life Center offers to Moultrie County. They do have a new STI test and treatment available.

Deb- asked Skylar how many surveys she has as her goal for Moultrie. Skylar 5% for Moultrie would be 750.

Kristin- works with youth serving organizations to help them integrate substance use prevention into the services that they're already providing at whatever capacity that they have. We're also available to provide technical assistance and just knowledge on what good prevention is and how to best serve our communities.

Skylar- told everyone that she is transitioning to the Coles County Coordinator position. It will be a slow transition, and we will have more details about that at the next meeting.

Community Survey

Skylar checked the numbers on our google form for how many surveys we have completed. The number had been 109 on 10/6. When **Skylar** checked with the council it was 115. Kandis was

out in the community on 10/6 sharing QR codes with local businesses and establishments. **Skylar** thinks that definitely upped the numbers!

Skylar listed all of the places she had taken the survey to so far for outreach. She shared the link to the survey in the Zoom chat and asked if anyone had not completed it, to complete it. She also encouraged everyone to share it with their contacts and on social media.

Step into Purple

Our first Recovery Walk was a success. It was a small event but very intimate and meaningful. The News Progress came to do a piece on the event. The 6 of us in attendance walked around the pond at Wyman Park, across the bridges and talked about why we walked that day.

Resource Guide

One of our priority projects for Moultrie County ROSC is to increase accessibility and availability to recovery supports and services within the county. A consistent barrier is a lack of knowledge of where to find resources and transportation to get to them. We decided that creating a user-friendly guide would be a first step in helping to connect people and bridge this gap. The guide was created by **Skylar**, sent out to the council email list for edits and then review during the council meeting.

Deb asked if Moultrie was going to create their own ROSC logo like some of the other council have been. **Skylar** mentioned that she wanted to leave that up to the new ROSC Coordinator but was undecided.

Kristin mentioned that when she is working with all different counites it is helpful to have a different logo specific to each county because it helps to know what you're looking at. Deb offered to send **Skylar** other counties logo ideas.
