Discussion

The council went over the Community Survey question by question and came up with some updates they would like to see for FY26.

- The first 10 questions will remain the same because they are required by DBHR.
- Jessica S. suggested sharing the survey in-person at any of our events. Taking a clipboard and explaining what it is for and then asking attendees to fill out the survey.

- Angie Bailey suggested we make a flyer with QR Code that we could share it on HSIDN weekly updates and ask that it be promoted throughout Franklin/ Williamson counties.
- Jordon Suggested separating the ROSC questions from the FW ROSC questions.
- Teea suggested we use Google Docs and Mike D agreed.
- Mike D suggest we use “Youth Empowerment” to spread surveys at events because adults can’t say no to kids.
- Sherry S suggested all of our agencies making sure we all share the survey with our offices that are serving participants but also our staff.
- Beverly said, we need to make sure the questions cover the demographics, measuring the attitudes and exposing the gaps in communities we serve.
- Shae D suggested that we allow multiple choice for several of the questions.
- Mike D asked if there would be multiple choice or fill in the box, there was much discussion on the types of questions and the formats of each one for instance adding a box with statement for adding their thoughts.
- Kelli C suggested that we give them the chance to tell us what they believe in the questions.
- We will be replacing the homeless questions with transitional housing questions with the survey.
- Mandy asked if anyone would commit to being on a subcommittee to finalize the survey – Christina M, Sherry S, Teea F and Jessica S, volunteered. They will meet separately.
- We spent much of the meeting discussing the Community Survey so did not get to discuss all agenda items.
