Agency Updates

Nathan- Central Illinois Public Transit is celebrating National Rural Mobility Week with FREE rides all day November 7th. Check out the Central Illinois Public Transit Facebook page, that is where they post frequent updates on what they have going on.

Becky- Dove Inc. has asked Moultrie County ROSC to partner with them at their Santa's Little Helper Workshop. The flyer can be found on the Chamber website and on Facebook! Becky also mentioned Dove's recent Domestic Violence Candlelight Vigil where Moultrie County ROSC accepted an award from Dove.

Skylar introduced Josh Forbes as the new Moultrie County ROSC Coordinator. Josh will be training with Skylar and other ROSC Coordinators in our area to soak up all of the information and get acquainted with his new position.

Community Survey

Skylar shared her and Kandis' efforts with trying to get Community Survey responses. Skylar has reached out to the schools in Sullivan and she has asked businesses to share on their Facebook. Our goal is 5% percent of the population in Moultrie County. That would be 750 and we have about 120.

Josh, Kandis and Skylar will be working together over these last few weeks to try to get as many responses as possible.

Events

Free Laundry Day is on November 20th from 9am to 12pm. Reminder that we go until 12 OR until funds run out. This laundry day is sponsored by the Highway Church of Christ and they will have members volunteering at the event.

Kandis has continued education groups at the Elizabeth Titus Memorial Library, every Monday at 12. She had one participant on 10/27.

Kandis also gave us an update on the Community Narcan Training that ROSC hosted on October 27th. There were 5 community members present, they asked a lot of good questions and 10 boxes of Narcan were dispensed.

Priority Project #1

Increase the accessibility and availability of recovery supports within the County, ensuring that individuals in need are aware of, and able to access recovery resources and services.

Skylar stated that she is still working with her supervisor on edits to this resource guide. She will send it out as soon as it is completely ready.

Skylar, Josh and Kandis plan to visit Dalton City before the end of this month to introduce ROSC and to try to get a DOPP site set up.

Priority Project #2

Work with stakeholders to establish the use of MAR in local jails.

Skylar reminded everyone of the Medication Assisted Recovery training that Douglas County ROSC is hosting. Participants could attend via Zoom or in-person. The flyer will be sent out to the council again.

No new progress has been made toward MAR in Moultrie County Jail, but, we do know that the jail administrator is going to try to attend the training in Douglas county.

Priority Project #3

Assist Moultrie County court in exploration of the development of a drug court.

Skylar and Kandis had a productive meeting with Moultrie County Probation about substance use and recovery in our community. We started the conversation about drug court and plan to

gather more information from neighboring counties about what it looks like to get a drug court up and running in a rural community.

Liesl Wingert informed the council about some funding that is going to be made available regarding drug courts in rural areas. She is going to connect with Skylar as soon as she is able to regarding this application.
