

Services Offered: In addition to full medical services offered at Touchette they offer an expanded Behavioral Health & Wellness Center/Department which offers quality and compassionate behavioral mental health care for the region. Mental illness touches all walks of life. Individuals dealing with mental illness deserve quality care regardless of their financial status. The Behavioral Health & Wellness Center provides outpatient and inpatient care. Their services are designed to incorporate several successful treatment modalities into a comprehensive, flexible, and individualized mental health treatment program.

Services include Outpatient Services, Adolescent Intensive Outpatient Program, Medical Stabilization, Adult Substance Abuse, Intensive Outpatient Programs, and an Electroconvulsive Therapy Program.

Services Offered: The St. Clair County Child Advocacy Center offers a team of specially trained interviewers, case managers and counselors ready to provide children and families complete support throughout the healing process. The Child Advocacy Center is a non-profit organization that provides a safe, child-friendly environment for conducting forensic interviews and medical evaluation. They assist with investigations of sexual and serious physical abuse of children, as well as interviews of children who have witnessed violent crimes. Working with a multi-disciplinary team, they reduce the number times a child must repeat details of the incident, thus minimizing the trauma a child experiences through re-telling their story. This also allows them to expedite cases through the judicial system.
