MEETING MINUTES

Tuesday November 18th, 2025

- 2. **Presentation** by Lisa Massa from Department CFS:

Lisa Massa, a long-time DCFS staff member and foster parent of four siblings, emphasized the urgent need for qualified foster families in Clinton County. Lisa shared current data showing that in Fall 2025, less than 3% of children in the county required removal from their homes for safety reasons. As of November 2025, 59 youth from Clinton County were placed in foster care. Demographics include: 59% Caucasian, 33% Black, 8% Hispanic, 0% Asian. Age groups are: 42% ages 0–5, 32% ages 6–12, 19% ages 13–17, and 7% ages 18+.



She noted the ongoing challenge of finding homes willing to accept children, especially Spanish-speaking homes.

Basic qualifications for foster care providers include:

- Being 21 or older
- Single, married, divorced, or legally separated
- Completing a medical exam
- Having adequate home space
- Being financially self-supporting

Foster parents receive reimbursement stipends, WIC benefits, and access to other supports. Lisa highlighted that the greatest reward is making a positive impact—supporting vulnerable children, serving the community, and experiencing meaningful emotional fulfillment.

- 3. **Community Survey:** IGA gave us permission to solicit Saturday, Nov 15th to distribute survey QR code cards and paper surveys to patrons, we increased the number of takers of the survey from 122 to 130. The link is below and QR code to the right to share with community members.

 - We will start contacting organizations to sign up on Microsoft forms to get accurate count of who will attend by the beginning of December.
 - Will help with funding of banners & advertisements Nellie to send over to me to send to the state for approval.

B. RCO Development Work Group

- Collaborate with folks like Tyrone Hill, Jon Magnuson, Mike Tyson, & Nellie Pascavich
- The plan is to engage with these RCO developers by the end of December

C. Access to Community Health Work group
