Mandy will be dedicating most of her time to PJRC and really evaluating the ROSC council and adjusting the council goals to fit the needs strictly of Perry/Jackson Counties.

Michelle Buckley updated us on the accountability standards they have placed within the Marion Oxford House and how they will continue to implement these standards throughout the program structure.

They are still planning on opening a women's home in Carbondale by the beginning of the new year!

Oxford is going into Gateway in Carbondale now, to both men and women's residential, to present on Oxford transitional housing to obtain referrals.

Mandy stated how important it is for ALL of our recovery service agencies to come together for the Town Hall.

Mandy met with Quiana from CHESI and will be connecting with them to bridge gaps between participants and their healthcare needs.

IMPORTANT: HOW CAN ALL UTIILIZE ANOTHER'S SERVICES?

- This will be our main goal as we move forward during FY26!

Carbondale Warming Center will be meeting with TAT to try to discuss upcoming crisis weather plans. (Will discuss at next meeting)

Kelsey discussed Carbondale TAT Resource center October monthly visits:

- 12 Male/Female first contact forms
- 242 total visits: 38 female/ 204 males
- 80 loads of laundry
- 141 showers
- 204 meals
- 76 received donations
- 17 people used computer services
- 12 referrals
- 13 transports
- 2 volunteers, 23 days this month

Torie Patton updated the council on the Harm Reduction program October numbers:

- 944 units of Narcan distributed
- 24 fentanyl test strips distributed
- 40 overdose awareness kits distributed
- 5 individuals were assisted in filling out housing applications
- 5 referrals made to community partners
- 2 new MOU's signed with community partners
- 32 individuals trained to administer Narcan
- 60 individuals were reached during outreach
- 3 new participants
- 1 participant went to residential treatment
- 1 participant went to detox

Torie trained the Rick Warren Library staff last month on how to administer Narcan and now one of our volunteers who works there has been approved by the board to partner with us and host a FREE Narcan training quarterly at the library from here on out!

This is what we want to see, we want to see our agencies training community members to bridge the gap in those areas and help spread awareness and education while breaking down the stigma surrounding substance use, harm reduction services, and recovery!
