Updates on Program Deliverables and Community Events

Rachel shared progress on program deliverables, highlighting the submission of a community resource booklet and the development of a recovery guide pamphlet. Booklet is available- just ask and I will send or print copies for your workplace. An updated list of community resources can be found on the Jersey County Health Department website, and QR code business cards with that link are available. Thank you Becky! Will send out recovery pamphlet to council for input. Upcoming deliverables include survey raw data as well as the strategic plan, both due at the end of December. Survey goal for the first year 54/75- not awful for the first year with our council. Two more upcoming events will wrap up the survey and we are hoping to get a few more by then. A jotform will be going out to members regarding the SWOT analysis, which will help us in shaping our strategic plan. Responses to the form are appreciated but not required! She announced a Narcan training session scheduled for Friday 11/14/25

@2pm @ Koen Counseling and Wellness. She also discussed a community event involving gingerbread house/hot cocoa bar & networking and resource night. Discussion was had regarding December event: free pictures with Santa and resource/meet and greet night. Klocke also sought input on potential locations for a 24-7 Narcan distribution station. Potential locations include: Lion's park, near the courthouse, near CVS/ liquor store down the road, city center park? We will reach out to JPD for their input on hotspots and more to come with this.

Development of Recovery Peer Programs in Jersey County

Discussed partnering with Recovery Corps and being a site partner. They will interview, train and pay the individual, while JCHD/ROSC houses/supervises them. Explored the development of a warm handoff program for Jersey County, focusing on the involvement of peers in supporting individuals in recovery. Emily pointed out the barriers in the drug court program, where case management often detracts from therapy, and proposed that peers could facilitate pro-social activities to enhance engagement- quarterly after the first of the year? They also discussed the potential for creating a non-religious support group to better serve the community's needs. Meaghan suggested that we connect our peer with Sacred Spaces of Care peers to help jumpstart our peer work as well as providing vital documents for client tracking. Brief discussion on SMART recovery training took place. Erin Hileman showed interest, would be good for the peer to do as well to aid them in initiating their own recovery groups. More to come with this.

Warm Handoff Work Group Discussion

Rachel initiated a discussion on creating a warm handoff work group to develop policies for connecting peers with individuals requiring assistance. This work group will meet at 11am before ROSC meeting next month-December and then prior to the ROSC meeting in the following months. Sarah Crawford highlighted the role of EMS in overdose cases and suggested that peers could follow up with patients who refuse hospital transport. The conversation also touched on the stigma surrounding peer support and the necessity of obtaining consent for follow-up communications. Warm handoff will also hopefully be utilized in the local ER and police stations. Current use of MAR now in these facilities will hopefully ease our transition into these spaces.

Podcast Development and Meeting Wrap-Up

Rita from Jersey County Against Drugs, highlighted the progress of their podcast, P3D Pawdcast, which is now in its fourth year, and noted the transition from audio interviews to video formats. She emphasized the importance of community involvement, mentioning that they have featured individuals in recovery and other local figures.
